1. **Approval of Minutes:** 4 26 22 Minutes approved.

- 2. Discussion with Matt Manson, Blackies, and Chris Peircey, Auburn Schools Nutrition Director: Discussion centered on work being done to get local produce into school lunch program. Crops availability doesn't always line up with school schedule. Whole foods are not convenient for schools due to preparation requirements and staff limitations. Auburn serves about 1500 lunches a day. State reimburses 33% of cost of up to \$5500 a year for local products. Farmers need access to processing and packing capability to get product into schools. There have been discussions about putting a commercial kitchen at Pettengill Park. Katie will check on where that project is. Another possibility is to get a grant for a flash freezer and storage capacity. Local food use is currently about 3% in Auburn schools. Staff is a limiting factor. Blackies is exploring a grant for warehouse and processing capacity.
- 3. Discussion with Paul Peters, Ag Consultant, on PFAS: Paul said there is not a lot of knowledge about PFAS impact at this point, either the extent of a health threat or future impact on soils and agriculture. The State is aggressively studying these issues, measuring and monitoring PFAS levels. U Maine is also conducting research. State dollars are available to help farmers.
- 4. Speakers: Pam is working on a speaker on Crazy Worms for the next meeting.
