RE: Legal Peaces, 197 Turner Street, Auburn, Maine – Petition for Appeal of Certificate of Occupancy

Dear Members of the Board of Appeals:

In anticipation of the Board of Appeals meeting scheduled for September 24, 2018 to hear an appeal filed by Shanon and Vincent Gogan, d/b/a Legal Peaces, the City of Auburn Office of Planning and Permitting and the Office of Economic and Community Development (the “City”) has requested that I prepare a letter to you summarizing the City’s position concerning this matter.

Subject of the Appeal

Legal Peaces is appealing the City’s issuance of a certificate of occupancy (“CofO”) for its premises located at 197 Turner Street because the CofO limits use of the premises to a tobacco smoke shop and does not authorize Legal Peaces to use the premises as a medical marijuana caregiver storefront.

Background and Permitting History

By way of background, Legal Peaces submitted a commercial building permit application on May 9, 2018 for a change of use of the premises from office space to a medical marijuana caregiver storefront and to renovate a bathroom. The building permit issued on May 18, 2018, with a condition that Legal Peaces secure a CofO before occupying the premises. (See Attachment 1.) A copy of the building permit was delivered to Legal Peaces on June 1, 2018.

On or about May 29, 2018, after completing the bathroom renovations, Legal Peaces contacted the City to request that the City complete a final inspection of the premises, as required prior to the issuance of a CofO. A City inspection was scheduled for June 1, 2018; however, the

applicant requested that the inspection be rescheduled. Accordingly, the inspection was rescheduled for and occurred on June 4, 2018.

The City issued the CofO a week later, on or about June 11, 2018, and delivered a copy to Legal Peaces on June 13, 2018. (See Attachment 2.) The CofO authorizes a change of use of the premises “from office space to retail store (Tobacco Smoke Shop)” but states that it “does not authorize any uses of the building premises or the retail sales of goods that are not authorized under state law.” On June 11, 2018, I advised Legal Peaces by letter that the CofO does not authorize the retail sale of medical marijuana. (See Attachment 3.)

On June 15, 2018, Attorney Matt Dubois, counsel for Legal Peaces, submitted a letter to the Office of Planning & Permitting appealing to the Auburn City Council the City’s “refusal to issue a Certificate of Occupancy for their caregiver business.” I advised the City Clerk to place this matter on the next City Council agenda, but informed Mr. Dubois that I would advise the City Council that it does not have jurisdiction to take up the appeal. On July 6, 2018, Mr. Dubois advised me that Legal Peaces would file a new petition for appeal.

On July 9, 2018, the City received a petition for appeal on behalf of Legal Peaces seeking an appeal of the City’s “refusal to issue a certificate of occupancy for my clients’ caregiver business,” and requested that the appeal be taken up by “whichever reviewing body is responsible for hearing appeals regarding certificates of occupancy.” (See Attachment 4.)

After discussion with Attorney Michael Malloy, general counsel for the City, and Mr. Dubois regarding the proper administrative jurisdiction for this appeal¹ and related scheduling matters, the petition for appeal was scheduled for a hearing before the Zoning Board of Appeals on September 24, 2018.

The Moratorium Ordinance

On June 18, 2018, the City Council enacted a moratorium on medical marijuana caregiver storefronts. The moratorium governs and applies to all proceedings, licenses, and applications for medical marijuana caregiver storefronts that were or are pending before the City on or any time after May 31, 2018. The moratorium also nullifies the issuance of any final approvals of the City Clerk, Code Enforcement Officer, or the Planning Board made on or any time after May 31, 2018 that authorizes the operation of a medical marijuana caregiver storefront. (See Attachment 5.)

The City Council selected May 31, 2018 as the date of applicability of the moratorium ordinance because that was the date when information that the City Council would be considering a moratorium on medical marijuana caregiver storefronts was first published on the City’s website as part of a packet of materials attached to the City Council’s June 4, 2018 workshop agenda. (See Attachment 6.)

On June 22, 2018, I advised Mr. Dubois in writing of the effect of the moratorium on his clients' various filings, including the initial appeal petition concerning the CofO. (See Attachment 7.)


Analysis

The moratorium governs and applies to “all proceedings, licenses, and applications for a . . . Medical Marijuana Caregiver Storefront that were or are pending before the City Clerk, Code Enforcement Officer, or the Planning Board on or any time after May 31, 2018.” Although Legal Peaces' request to issue the CofO was made prior to May 31, 2018, it could not be processed without an inspection of the premises. That inspection occurred on June 4, 2018. Accordingly, the CofO request became a pending proceeding on the date of the inspection.² At that time, the City was without authority to issue a CofO for a medical marijuana caregiver storefront. Instead, the City issued a CofO for those proposed uses that were not affected by the moratorium—namely, the tobacco smoke shop.

In addition, the moratorium nullifies the issuance of any final approvals that City officials make on or after May 31, 2018 concerning medical marijuana caregiver storefronts. Because the CofO issued by the City on or about June 11, 2018—after the May 31, 2018 date of applicability—it would have been nullified by the moratorium to the extent it authorized a medical marijuana caregiver storefront. The City avoided this result by issuing a CofO that is limited to the tobacco smoke shop. Moreover, the City cannot now issue a CofO to Legal Peaces for a medical marijuana caregiver storefront while the moratorium is in effect.

For all of the above reasons, while the moratorium is in effect, the Zoning Board of Appeals is deprived of authority to take up Legal Peaces' appeal of the CofO. In addition, to the extent that Legal Peaces' appeal involves a challenge to the validity of the moratorium ordinance itself, the Zoning Board of Appeals should refuse to hear the appeal on the ground that it lacks jurisdiction to determine the validity of a legislative enactment.³


As you know, I represent the City of Auburn in the above-identified matter. I understand that your clients, Vincent and Shanon Gogan d/b/a Legal Peaces, submitted an application on May 31, 2018 for a pre-packaged food establishment business license and are awaiting receipt of a certificate of occupancy (“COO”) from the City to change the use of a pre-existing office building to a retail store for the sale of tobacco products, pre-packaged food, and medical marijuana.

In your letter to Mr. Eric Cousens, dated June 5, 2018, you assert that the license and COO has not issued because of a “discriminatory intent specifically to shut down my clients’ business.” To the contrary, the license and COO has not issued because, at your clients’ request, the inspection that had been scheduled for Friday, June 1, was cancelled and rescheduled for Monday, June 4, which resulted in some delay in processing the application. It also bears mention that the City’s Business License Application expressly states that there is a 14-day review period after the receipt of a completed application. Moreover, the license application submitted by your clients, and the inspection conducted on June 4, has raised some question as to whether your clients’ proposed retail sale of medical marijuana at 197 Turner Street is a lawful use under applicable state statutes and rules.

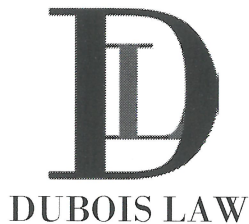
Pursuant to Article II, Section 14-26 of the City’s Code of Ordinances, all applicants for business licenses are required to comply with state statutes and rules which pertain to the business or activity for which a license is desired. The burden is on your client to satisfy all applicable ordinance provisions. Accordingly, I have advised the City to issue a limited license and COO authorizing your clients to engage in the sale of tobacco products and pre-packaged foods, but not authorizing the retail sale of medical marijuana from this business location.

To the extent your clients wish to expand the City’s authorizations to include the retail sale of medical marijuana at 197 Turner Street, please submit evidence, such as a statement from the Maine Department of Health and Human Services, that your clients’ intended retail caregiver medical marijuana storefront complies with the Act and related state rules.

Subject: Marijuana Moratorium

Information: The marijuana workgroup has been meeting regularly since the City Council meeting on February 5, 2018 to consider local impacts relating to adult use marijuana to include medical marijuana retail. The workgroup will have a report to present to the council at a future meeting.

At the request of City Councilor Andy Titus, this workshop is being held to determine the action that the City Council will need to take regarding medical retail caregiver “storefront” operations. As such, the committee recommends that a moratorium ordinance be enacted to allow the Legislature and involved state agencies to finalize the statutory and rule amendments. Currently, the City of Auburn Code of Ordinance is insufficient to prevent serious public harm that could be caused by the unregulated development of retail marijuana establishments and other uses authorized by the “Marijuana Legalization Act” approved at the November 8, 2016 referendum election, thereby necessitating a moratorium to provide an opportunity for the city to amend its code of ordinances to mitigate the potential impact and harm on the city and its residents.

While the “Marijuana Legalization Act” has been approved, the rulemaking has yet to be completed. In addition, the city has had four (4) medical retail storefronts begin unregulated operations. In addition, Police and Code Enforcement have received several inquiries regarding retail and medical retail operations.

Workshop follow-up from June 4, 2018

The city council requested further clarification regarding when the moratorium would be in effect and any additional impacts. Legal counsel will be available to answer any questions. A revised draft moratorium ordinance is attached.

City Budgetary Impacts: A moratorium would have no direct budgetary impacts.

Staff Recommended Action: To adopt a marijuana moratorium for medical retail “storefront” operations with an effective date of May 31, 2018.

Previous Meetings and History: December 5, 2016, January 23, 2017, February 5, 2018, and June 4, 2018.

CITY OF AUBURN CITY COUNCIL

MORATORIUM ORDINANCE ON SOCIAL CLUBS AND RETAIL MEDICAL MARIJUANA CAREGIVER STOREFRONTS

The City Council of the City of Auburn, Maine (the “City”) hereby amends the City’s Code of Ordinances by adding the following words to Chapter 61, immediately following Chapter 60 (Zoning):

CHAPTER 61. MORATORIA

ARTICLE I. MORATORIA

Sec. 61-1. Moratorium on Social Clubs and Retail Medical Marijuana Caregiver Storefronts.

WHEREAS, the Maine Medical Use of Marijuana Act, codified at 22 M.R.S. §§ 2421 to 2430-B, (the “Medical Act”) authorizes the possession, cultivation, and furnishing of medical marijuana to qualifying patients by caregivers, as those terms are defined in 22 M.R.S. § 2422; and

WHEREAS, section 401 of the Marijuana Legalization Act, codified at 28-B M.R.S. ch. 1 (the “Adult Use Act”) authorizes municipalities pursuant to home rule authority to regulate adult use marijuana establishments, including cultivation facilities, products manufacturing facilities, testing facilities, and marijuana stores, as those terms are defined in 28-B M.R.S. § 102; and

WHEREAS, neither the Medical Act nor the Adult Use Act nor any state agency rules promulgated thereunder expressly authorize the operation of retail stores by registered caregivers for the purpose of selling medical marijuana or medical marijuana products to qualifying patients (hereafter, “Retail Medical Marijuana Caregiver Storefronts”) or the furnishing or sale of marijuana or marijuana products to consumers for on-premises consumption (hereafter, “Social Clubs”); and

WHEREAS, during the first regular session, the 128th Maine Legislature considered LD 1539, “An Act to Amend Maine’s Medical Marijuana Law,” which, if enacted, would amend the Medical Act to expressly authorize the operation of Retail Medical Marijuana Caregiver Storefronts, and LD 238, “An Act to Amend the Maine Medical Use of Marijuana Act,” which, if enacted, would expressly authorize municipalities to regulate registered caregiver operations; however, the ultimate disposition of LD 1539 and LD 238 is unknown at this time; and

WHEREAS, no specific regulations governing Social Clubs or Retail Medical Marijuana Caregiver

Storefronts exist under the City's Code of Ordinances; and

WHEREAS, the City's Code of Ordinances is insufficient to prevent serious public harm that could result from the unregulated siting and operation of Social Clubs or Retail Medical Marijuana Caregiver Storefronts within the City; and

WHEREAS, the unregulated siting and operation of Social Clubs or Retail Medical Marijuana Caregiver Storefronts within the City raises legitimate and substantial questions about the impact of such facilities and related uses and activities on the City, including questions as to compatibility of such facilities with existing and permitted land uses in the City; potential adverse health and safety effects on the community; the adequacy of the City's infrastructure to accommodate such facilities; and the possibility of unlawful sale of marijuana and marijuana products; and

WHEREAS, as a result of the foregoing issues, the siting and operation of Social Clubs or Retail Medical Marijuana Caregiver Storefronts and related uses and activities within the City has potentially serious implications for the health, safety, and welfare of the City and its residents and visitors; and

WHEREAS, an overburdening of public facilities and resources, including public safety resources, is a reasonably foreseeable result of unregulated Social Clubs or Retail Medical Marijuana Caregiver Storefronts and related uses and activities located and operated in the City; and

WHEREAS, the City has established a working group charged with studying, reviewing, and making recommendations to the City Council regarding the regulation of adult and medical marijuana facilities, uses and activities, including Social Clubs and Retail Medical Marijuana Caregiver Storefronts; and

WHEREAS, the City and the working group needs time to understand the disposition of LD 1539, LD 238, and any State department rules promulgated pursuant to the Adult Use Act or the Medical Act in relation to its own Code of Ordinances and to evaluate the effects of Social Clubs and Retail Medical Marijuana Caregiver Storefronts and related uses and activities in order to prepare reasonable ordinance provisions governing the siting, licensing, and operation of such facilities, uses, and activities; and

WHEREAS, 30-A M.R.S. § 4356 authorizes the City to establish a moratorium on the processing or issuance of development permits or licenses; and

WHEREAS, in the judgment of the City Council, the foregoing findings constitute a necessity within the meaning of 30-A M.R.S. § 4356.

NOW, THEREFORE, be it ordained by the City Council of the City of Auburn, Maine, as follows:

1. Moratorium. The City does hereby declare a moratorium on the siting, operation, or licensing of any Social Club or Retail Medical Marijuana Caregiver Storefront within the City. For purposes of this Moratorium Ordinance, these terms shall have the following meanings:

- a. "Social Club" shall mean any premises where marijuana or marijuana products are furnished or sold to consumers for on-premises consumption, excluding the personal adult consumption of marijuana or marijuana products pursuant to 28-B M.R.S. § 1501(2) or the consumption of medical marijuana or medical marijuana products pursuant to 22 M.R.S. § 2422 et seq.
- b. "Retail Medical Marijuana Caregiver Storefront" shall mean a retail store, a retail business, or an establishment that resembles a retail storefront in terms of signage, hours of operation, and accessibility to patrons (including without limitation retail use or retail space, as those terms are defined in Article I, Sec. 60-2 of the City's Code of Ordinances) where a licensed caregiver furnishes or sells marijuana or marijuana products to qualifying patients, as those terms are defined in 22 M.R.S. § 2422.

[NOTE: Paragraph 2, below, concerns the retroactive applicability of this Moratorium Ordinance. This provision will be up for discussion at the City Council meeting scheduled for Monday, June 18, 2018.]

2. Date of Applicability. Notwithstanding 1 M.R.S. § 302 or any other law to the contrary, and regardless of the Effective Date, this Moratorium Ordinance shall govern and apply to all proceedings, licenses, and applications for a Social Club or Medical Marijuana Caregiver Storefront that were or are pending before the City Clerk, Code Enforcement Officer, or the Planning Board on or any time after _____ and, to the extent allowed by 30-A M.R.S. § 3007(6), shall nullify the issuance of any final approval of the City Clerk, Code Enforcement Officer, or the Planning Board made on or at any time after _____ that authorizes the operation of a Social Club or Medical Marijuana Caregiver Storefront (the "Date of Applicability").
3. Effective Date. This Ordinance shall become effective immediately upon its final passage by the City Council (the "Effective Date") and shall remain in full force and effect for a period of 180 days, unless extended, repealed, or modified in accordance with applicable law.
4. Conflicts; Savings Clause. Any provisions of the City's Code of Ordinances that are inconsistent with or conflict with the provisions of this Moratorium Ordinance are hereby repealed to the extent applicable for the duration of this moratorium. If any section or provision of this Moratorium Ordinance is declared by a court of competent jurisdiction to be invalid, such a declaration shall not invalidate any other section or provision.
5. Violations. If any Social Club or Medical Marijuana Caregiver Storefront is located or operates in the City, in violation of this Moratorium Ordinance, each day of any continuing violation shall

Subject: Marijuana Moratorium

Information: The marijuana workgroup has been meeting regularly since the City Council meeting on February 5, 2018 to consider local impacts relating to adult use marijuana to include medical marijuana retail. The workgroup will have a report to present to the council at a future meeting.

At the request of City Councilor Andy Titus, this workshop is being held to determine the action that the City Council will need to take regarding retail and medical retail “storefront” operations. As such, the committee recommends that a moratorium ordinance be enacted to allow the Legislature and involved state agencies to finalize the statutory and rule amendments. Currently, the City of Auburn Code of Ordinance is insufficient to prevent serious public harm that could be caused by the unregulated development of retail marijuana establishments and other uses authorized by the “Marijuana Legalization Act” approved at the November 8, 2016 referendum election, thereby necessitating a moratorium to provide an opportunity for the city to amend its code of ordinances to mitigate the potential impact and harm on the city and its residents.

While the “Marijuana Legalization Act” has been approved, the rulemaking has yet to be completed. In addition, the city has had four (4) medical retail storefronts begin unregulated operations. In addition, Police and Code Enforcement have received several inquiries regarding retail and medical retail operations.

City Budgetary Impacts: A moratorium would have no direct budgetary impacts.

Staff Recommended Action: To adopt a marijuana moratorium for retail and medical retail “storefront” operations beginning June 18, 2018 and shall remain in effect until December 17, 2018.

Dear Matt:

As you know, on Monday, June 18, 2018, the Auburn City Council enacted a moratorium on retail medical marijuana caregiver storefronts. The moratorium governs and applies to all proceedings, licenses, and applications for retail medical marijuana caregiver storefronts that were or are pending before the City on or any time after May 31, 2018. The moratorium also nullifies the issuance of any final approvals of the City Clerk, Code Enforcement Officer, or the Planning Board made on or any time after May 31, 2018 that authorizes the operation of a retail medical marijuana caregiver storefront.

City records indicate that your clients submitted a business license application for the sale of pre-packaged food at your clients' proposed retail medical marijuana caregiver storefront at 197 Turner Street on May 31, 2018, and that the license is currently pending before the City Clerk.

City records also indicate that your clients submitted an application on May 9, 2018 for a change of use of an office space to a tobacco shop and retail medical marijuana caregiver storefront, and that a certificate of occupancy for these premises was issued by the Code Enforcement Officer on or about June 13, 2018.

With respect to both the business license and the certificate of occupancy, you were advised by me on June 11, 2018 that these City approvals would be limited to authorizing the sale of tobacco products and pre-packaged foods but would not authorize the retail sale of medical marijuana. You were also informed that, to the extent your clients wanted to expand these approvals to include the retail sale of medical marijuana, your clients would need to submit evidence to the City that your clients' intended retail caregiver medical marijuana storefront complies with the Maine Medical Use of Marijuana Act and related state rules.

In response, on June 18, 2018, you submitted a snapshot of a one-page on-site assessment report completed by an investigator at the Maine CDC on May 14, 2018. In addition, on June 15, 2018, you filed a letter on behalf of your clients appealing to the Auburn City Council the City's "refusal to issue a Certificate of Occupancy for their caregiver business without further documentation."

Because the moratorium applies to all pending proceedings as of May 31, 2018, the City Clerk is without jurisdiction to act on your pending business license application. Likewise, because the moratorium nullifies the issuance of any final approvals that City officials made on or after May 31, 2018, the certificate of occupancy issued on June 13 is nullified by the moratorium to the extent it authorizes a retail medical marijuana caregiver storefront. The certificate of occupancy remains in effect with respect to your clients' operation of a tobacco shop.

With respect to your June 18 submission seeking to expand the City's approval of the certificate of occupancy to include authorization to operate a retail medical marijuana caregiver storefront, the moratorium suspends all proceedings and applications for retail medical marijuana caregiver storefronts pending on or after May 31. Accordingly, to the extent your June 18 submission can be considered a pending proceeding or application, the City cannot accept your request for processing because of the enactment of the moratorium.

Finally, with respect to your June 15 notice of appeal to the City Council, I have advised the City Clerk to place this matter on the next Council agenda. Please note, however, that I will be advising the Council that it does not have jurisdiction to take up your appeal. In light of this, please let me know if you wish to proceed with your appeal to the City Council.
