Tizz Crowley commented that she supports the appointment process but feels that changes are needed, adding that she will submit some recommendations.

She stated that she came to ask that the Committee consider her application for the Parks and Recreation Advisory Board and to consider a balance of interest and experience, a balance of men and women if possible, and to make sure all ages are considered. She noted that the recreation is not just for sports and athletics, it includes leisure and lifestyle. Under the current ordinance, Parks and Recreation fall under a single Board and it is her feeling that Parks should fall under Conservation. She also asked that the Appointment Committee look seriously at Misty Edgecombe's application and consider nominating her to this board.
