This addendum amends and /or supplements the bid documents as indicated below. Only these items alter the bid documents. Any verbal discussions or responses are hereby declared null and void. Please acknowledge this addendum on page 5 of 6 of this Addendum.

# **Clarifications to the Bid Documents:**

The following changes have been made to the Bid Documents:

Q. Please supply more information regarding Items 603.199 & 603.239 such as location, existing culverts and sizes.

A. Item 603.199 and 603.239 are cross culverts. They are currently galvanized culverts and in need of upgrade to HDPE. Item 603.199 can be found at the intersection of Pownal Road and Jordan School Road on the north side of the intersection crossing Pownal Road. The other location is near address 1249 Pownal Road. Item 603.239 will replace an existing 48" culvert and can be found near 1359 Pownal Road. The plan is to submerge the 60"HDPE culvert 23 inches to provide better wild life passage and adequate drainage from the existing culvert.

Q. Are either of the Items 603.199 or 603.239 locations to be considered in-stream work and possibly need to postpone the completion date?

A. Item 603.239 60" HDPE is listed under the Maine Statutes Title 38: Waters and Navigation Exceptions and will not need a Pemit-By-Rule through the DEP. However, the completion date for the project shall be changed to September 29, 2017.

Q. Can Item 603.239 be SaniTite Pipe instead of HDPE?

A. Only HDPE material will be accepted. The quantity for this item shall be changed to 60 linear feet instead of 42 linear feet. (New Bid Form attached)

Q. What is the City's budget for this project? A. \$1,000,000.00

Q. Can the bid opening be changed to Thursday, December 8<sup>th</sup>?

A. The bid opening date will remain unchanged from Tuesday, December 6<sup>th</sup>.

Q. What is the extent of the work area?

A. Trapp Road between the 'Y' to capture the existing cracks to the other side of the intersection with Jordan School Road where the cross culvert patch is noticeable. Partridge Lane will need to be tapered back to match the new grade of Pownal Road at that intersection.

Q. How was Item 304.14 A-Gravel estimated? It seems very inflated.

A. This item was based on the length of 8,500 feet long road with 26-foot wide base (24' road and two 1' shoulders) at 1-foot depth. The gravel items are based on loose cubic yards, not in place cubic yards. The intersections may need additional gravel once the pavement is removed and the base material is found to be inadequate.

Q. Where are the 12 trees?

A. The trees are not delineated at this time thus far in the process. Residents will be contacted and the quantity cannot be verified until responses are received. The plan is to remove the trees dangerously close to the road. The majority, if not all of these proposed trees are on the side of the road away from the utility lines. Public Works is going to complete right-of-way clearing prior to construction.

Q. Will there be a need for box cutting, specifically driveway connections. A. There will be some excavation at the driveway match line to place 12" A-Gravel. The intent is to remove the pavement to the determined match line in the driveways and add gravel and HMA to match the new road elevation.

Q. Can the road be closed during installation of Item 603.239 60" HDPE? A. No, the extension to 60LF of the culvert will allow room to work on the culvert in sections while keeping one lane open.

Q. Please provide more information on the common borrow item added during the prebid meeting.

A. See updated Section 203

# SUPPLEMENTAL SPECIFICATIONS SECTION 203 – COMMON EXCAVATION

The provisions of Section 203 of the Standard Specifications shall apply with the following additions and modifications:

## 203.01 Description

This item shall be used for construction of driveway aprons and matching intersections. This item includes pavement removal of driveway aprons. Common borrow shall be used to add fill to the inslopes after raising the road. This item is also anticipated to be used in steep areas after constructing the new driveway entrances to match the higher road grade.

# 203.19 Basis of payment

The accepted quantity of excavation and borrow will be paid for at the contract unit price per cubic yard which price will be full compensation for removing and hauling the material, and for obtaining borrow when required.
