Resolution #2937

BE IT RESOLVED by the Commissioners of Auburn Housing Authority that a charitable donation in the amount of \$500,000.00 be made from the Authority's unrestricted Barker Mill account reserves to Auburn Residential Development Corporation (ARDC) for housing development needs in the City of Auburn. ARDC shall restrict the use of funds to the creation, preservation or operation of affordable housing, consistent with ARDC's charitable purposes. Until use of the funds ARDC shall invest the Auburn Housing Authority-donated funds hereby authorized in FDIC insured (or properly collateralized/privately insured) interest-bearing account(s) or certificate(s) of deposit. Use of the donated funds (including investment earnings) shall be restricted and subject to approval of the ARDC Board of Directors. ARDC shall generate periodic status reports on the outstanding balance of the donated funds, interest income derived from the funds, and any periodic disbursement of funds for the aforesaid acquisition purpose.
