

Executives Sessions: On occasion, the City Council discusses matters which are required or allowed by State law to be considered in executive session. Executive sessions are not open to the public. The matters that are discussed in executive session are required to be kept confidential until they become a matter of public discussion. In order to go into executive session, a Councilor must make a motion in public. The motion must be recorded, and 3/5 of the members of the Council must vote to go into executive session. An executive session is not required to be scheduled in advance as an agenda item, although when it is known at the time that the agenda is finalized, it will be listed on the agenda.

The only topics which may be discussed in executive session are those that fall within one of the categories set forth in Title 1 M.R.S.A. Section 405. Those applicable to municipal government are:

- 1. Discussion of personnel issues
- Discussion or consideration of the condition, acquisition, or the use of real or personal property or economic development if premature disclosure of the information would prejudice the competitive or bargaining position of the body or agency.
- 3. Discussion of labor contracts and proposals and meetings between a public agency and its negotiators.
- 4. Consultations between a body or agency and its attorney
- 5. Discussion of information contained in records made, maintained or received by a body or agency when access by the general public to those records is prohibited by statute.
- 6. Discussion or approval of the content of examinations administered by a body or agency for licensing, permitting or employment purposes
- 7. Consultations between municipal officers and a code enforcement officer relating to enforcement matter pending in District Court.

Problem Type: Homelessness and Transient Living on Public and Private Property

Problem Identified: Transients and their accompanying behavior (loitering, panhandling, substance abuse and aggressiveness) create negative economic impact on local businesses, increased fear of crime among citizens, increased calls for police service, and deterioration of the community's aesthetics.

Objective: Key objectives include the following:

- Partner with an independent social service organization to provide alternative housing, long-term rehabilitation programs, counseling and job placement to transient individuals.
- Reduce the number of transient persons.
- o Reduce the number of calls for police service related to transient people.
- o Positively impact the community's feeling of safety.
- o Improve the community's physical environment.
- o Provide appropriate shelter and adequate nutrition for transient persons.

Approach/Methods (Summary): A citywide community policing effort will result in the formation of a community partnership devoted to relocating transient people from the street and providing other services to help them become productive citizens. The first collaborative partnerships with the police department will include community leaders, local business representatives, church leaders, and social service agencies already providing services to help transients. Long-term rehabilitation and job placement will be emphasized to encourage transient individuals to learn how to care for themselves and eventually return to society as productive citizens. For those transients who do not want help and continue to be a public nuisance, municipal ordinances will be developed, including the development of a new city ordinance prohibiting public camping within city limits. Quality-of-life crimes (urinating in public, drinking in public, public drunkenness) will be aggressively enforced.

Immediate Action Plan:

- 1. Form an allegiance with storeowners to refrain from selling alcoholic beverages to known drunkards. A list of those transients who are known drunkards will be given to local storeowners.
- 2. A Letter of Agency¹ is a newly implemented law enforcement tool that allows officers to make trespassing arrests based on prior written request by a property owner. This is proving to be one of the best long-term solutions for unwelcome transients. This proactive approach, combined with counseling and referral services, will greatly improve the transient problem.
- 3. Enforce open hours for city parks.
- 4. Install higher-density halogen lights to brighten identified areas/parks after hours.
- 5. Make the extension of the Riverwalk into Moulton Field a priority by cutting back trees and shrubs to discourage "camping within city limits".

Results will include a dramatic decrease in calls for police service related to transient persons, a positive change in citizens' feelings of safety, and an improved economic climate for local businesses.

Partners: The police department could exert its leadership, but the effort has to be fully integrated with all city departments. Code enforcement, public works, parks and recreation, and building inspection departments must participate and embrace the concept of providing a better coordination of resources and delivery of service to Auburn's citizens to affect a positive impact. Partnerships need to be extended to outside organizations including Tri-County Mental Health, Department of Health and Human Services, Maine State Employment Department, L-A Trails, Androscoggin Land Trust, Community Based Organizations, local businesses and Faith Based Organizations.

Current Results: As of June 13th, the police department has been designated through a "Letter of Agency" with six private property owners. As a result, the department has issued fifty-three criminal trespass warnings and has summonsed two individuals for violating the written warning. Daily inspections of the area are being conducted by the patrol force ensuring compliance.



Re: Future use of Engine Two Station 180 South Main Street

Although we are currently working towards a Joint Public Safety Building to house Police and Central Station for Fire, Engine Two's Station will need to be considered in the near future. It no longer meets the needs of the department in size or function. The location I feel is fine, but for the future I would see a three bay station with a small substation for Police. With the continued build-up of housing developments, the possibility of a turnpike connector in that district, as well as containing the majority of our multiple story wood frame apartment buildings, I would suggest that in the future you would see an Engine Company, an Ambulance, and the Tower at that station along with the built-in substation for Police. Until a space needs assessment and feasibility study is done the square footage needed is unknown.

Dear Mayor John Jenkins,

On September 26th, 2007 at 7:15am an Auburn Middle School student was hit and injured by a school bus while in the crosswalk at Court Street and Falcon Drive. Since Sept. 27th, an Auburn traffic officer has been positioned at that crosswalk directing both cars and busses as well as crossing students during arrival and dismissal on nearly every school day. This was established immediately following the accident with the understanding that it was a temporary solution until a permanent one could be found. Numerous cries from the Auburn school administration and concerned citizens have fallen on deaf ears and no long term solution to this dangerous situation has been accomplished.

We have an obligation to correct this safety issue. We must ensure the safety of all of our students and the many community members who use this facility and its grounds all year long. Please see the attached information stating specific areas of concern regarding the entrance of Falcon Drive.

Our current information is that there will not be an officer positioned at the Falcon Drive crosswalk after the 2007-2008 school year. How will this safety issue be addressed prior to the late August start of the 2008-2009 school year?

We request immediate resolution to this serious safety issue in our city.

Specific Areas of Concern regarding the corner at Court Street and Falcon Drive (road leading to the Auburn Middle School and the Child Health Center) in Auburn Maine:

1) Method of traffic control and safe crossing of pedestrians needed.

Safety of students crossing Court Street and of drivers making a left turn out of Falcon Drive onto Court Street at stated location.

> Possible solution is to locate a traffic light at this spot that could include a weight sensitive or magnetic sensor to signal traffic looking to make a left turn (this would allow cycling only during high traffic departure times). The present situation cannot be charged to a school crossing guard as it involves not just crossing pedestrians but significant traffic control as well.

2) Drainage issues at the upper corner of Falcon Drive and Court Street create flooding during rain and icy pavement at that entrance during the winter.

Vehicles have been known to hydroplane on the standing water at this corner and numerous cars have sprayed walking children on the sidewalk as they enter Falcon Drive during wet weather. In the winter those same cars slide across the entrance and could easily encroach on the sidewalk when that same spot is frozen.

Possible solutions are to redirect water away from the entrance to Falcon Drive via culvert improvements or to re-grade the roadway to continue the runoff water down beyond the entrance.

3) Lack of sufficient lighting at the location for evening and winter safety of pedestrians and vehicles.

Lighting along Falcon Drive and in the school parking lots is lacking or in disrepair at this time. The single light across Court Street is insufficient to allow for proper viewing of pedestrians and vehicles exiting Falcon Drive.

A possible solution includes repair of existing lighting along Falcon Drive as well as installation of proper illumination both on school grounds and on Court Street at that entrance.

Petition requesting resolution of the safety issues at Court Street and Falcon Drive

We the undersigned registered taxpayers of the state of Maine request immediate resolution in the safety deficiencies at the location of Court Street and Falcon Drive in Auburn, Maine specifically to address the following:

- 1) Method of traffic control and safe crossing of Court Street for pedestrians at Falcon Drive entrance.
- 2) The drainage issue at the upper corner of Falcon Drive and Court Street which at present creates flooding during rain and icy pavement at that entrance during the winter.
- 3) The lack of sufficient lighting at the Falcon Drive entrance and Auburn Middle School parking lots.



Dear Residents of the Turner Street and Lake Auburn Avenue area:



Number of votes

Most municipalities are asked to vote for two candidates, because there are two elected LPC members for most districts. Some municipalities only vote for one candidate, because the other LPC member in that district is appointed. *You are instructed on the ballot (above the list of candidates) whether to vote for two candidates or just one*.

Candidate profiles

If you are not familiar with any of the candidates, please review the Candidate Profiles on the back of the ballot. Feel free, also, to contact the candidates directly.

Write-in candidates

In addition to the candidates listed on the ballot, you may vote for a candidate whose name you write in. The write-in candidate need not be from your municipality, but must be an elected or appointed official from a municipality in your Senate/LPC district. *Check to be sure the write-in candidate is willing to serve if elected!* Write-in candidates should be communicating their interest in serving among the municipal officers within their district.

If you are instructed to vote for two candidates and only one candidate is on the ballot, please use the "write-in" line for your second vote, if you know of someone who is willing to serve.
