

Fire

- AFD responded to a 2nd Alarm fire at 46 Fourth Street. This fire also involved a firefighter injury. The first notification (several minutes before the first phone call to 911) of the fire came in on the City's fire alarm system. This system was an equivalency given years ago by the Fire Prevention Office working with the property owner to meet a cost effective need for fire protection.
- Auburn Firefighter's responded to Lewiston to assist with a 2nd Alarm fire on Pine St. Once there, the crews revived a pet cat utilizing the department's pet rescue equipment.
- The department was very busy with calls as a result of the several snow events following last week's blizzard.
- > FPO O'Connell performed an occupancy inspection for several local businesses.
- AFD fire crews assisted Lewiston with a response for an individual who had their aluminum ladder fall onto power lines while removing snow from a roof. All Lewiston units were on emergency calls at that time.
- Lt. Jon Woodhead continued to provide fit testing for all personnel required to wear a respirator.
- Crews participated in refresher training on Hazardous Materials Operations level training and CPR recertification, a program taught by internal instructors.
- Firefighters hosted a troop of Cub Scouts and assisted then with a demonstration of basic first aid skills. This was part of a merit badge training for the scouts.

- For the week of January 29th to February 4th, we responded to 104 calls for service. These include, but are not limited to: 3 fire alarm call, 3 fire calls, one cooking, one vehicle and one second alarm structure fire, 71 Emergency Medical calls, 10 Motor Vehicle Accidents, 5 with injuries, 6 service calls and 6 Hazardous Condition calls, 2 natural gas main breaks (from snowplowing), and 1 RIT call to Lewiston. We provided 2 mutual aid assistances and received 2 mutual aids during this period. We also provided 1 EMS Mutual Aid call to Lewiston for UAS during this period.

Health and Social Services

- State billing was done this week for January expenditures. We assisted 28 households, 60 individuals for a total of \$5,612.
- In January, 9 households were assisted from our pantry with a variety of household supplies and food.

Human Resources

- Ray Lussier, Safety Consultant, distributed information on precautions for removing snow from rooftops. OSHA requires training on fall protection and other personal protective gear and we want employees to perform these functions in a safe manner.
- Chris Mumau, Human Resources Assistant and Debbie Grimmig, Human Resources Director attended a WorkMed presentation on updates to Federal Department of Transportation medical exams for CDL Drivers specifically as they relate to screening for sleep related disorders. Persons with sleep apnea and other disorders are at higher risk of developing serious medical conditions and have a higher risk of traffic accidents. The Human Resources Department will be working WorkMed to ensure that that appropriate screenings are included in pre-employment physicals for applicants for safety sensitive positions.
- Maine Municipal Employees Health Trust (MMEHT) subcontracts with Anthem to provide health insurance to City employees. MMEHT alerted the City that current and former employees may be affected by the recent data breach at Anthem. Anthem will be providing information directly to employees if they have been a victim of the data breach. In addition Anthem has established a website from which employees have obtain additional information. The Human Resources Department will be updating employees as soon as more information is available.

ICT

- Provided required GIS layers to Woodard and Curran. They are using these files as part of their work on our MS-4 Stormwater Compliance efforts.
- Created a series of draft maps for a large upcoming airport event.
- Completed successful download of data from ArcGIS Online. This was our first download of data that had been updated by Public Services on the new on-line data storage GIS data collection system. The data will be checked for quality control and archived on our server.
- We routinely back up all of our servers, with an eye towards disaster recovery. If one of our servers were to fail, we would be able to restore its data and applications. This resource is also helpful in recovering accidently deleted files, which has happened to departments twice this week.
- Staff continues to work towards preparing the FY16 Budget, in anticipation of Friday's deadline.
- Staff helped to password-restrict the "Machanics" wi-fi access point at the Public Services garage.

Planning

Sanitation Highlight –I want to note the higher quality of service that we deliver locally by taking on local restaurant inspections. Not only do we have safe restaurants for consumers, but the restaurants in Auburn often get back to business as usual faster than other part of the state after any incidents that force their closure. Saturday afternoon there was a fire in

the warming unit at Arbys that forced them to close and clean up the mess from the discharge of a fire extinguisher. The owner was very cooperative and remained closed Saturday afternoon to clean up and remove/discard items that were contaminated. In other parts of the State it is likely that the local fire responders would close the restaurant and they would not be allowed to open until the State inspects the facility the following week. Cristy Bourget, Sanitation Inspector went back Sunday morning at 7:30 am for a re-inspection in time for them to open on their regular schedule Sunday morning with less than a day of business time lost and a clean and safe facility providing food to the public.

- Permit Report In January we issued permits for \$811,000 in commercial and \$312,000 in residential construction. A majority of that permitting activity happened in the first 2 weeks of January with a slower second half to the month, likely because everyone was busy cleaning up snow. We are currently discussing a lot of large and small projects and we are optimistic about investment numbers for the coming year.
- Fire in New Auburn There was a fire in New Auburn at 64 Fourth Street that displaced 8 families last week. It appears that the building can be saved and we are working to encourage the owner to reinvest. We have given the tenants contact information for local rental property owners and have tried to help them find new homes. It has been very difficult to reach land lords this week because they are all busy trying meet immediate needs clearing snow at their rental properties and have little time to look at the longer term need to fill vacant units. If you are reading this and have a vacant unit please let us know and we can pass along your contact information to tenants that lost their homes.
- Planning Board Meeting February 10th The draft Downtown Form Based Code will be discussed by the Board at their 6pm Meeting in the Council Chambers. This is a totally new approach for Auburn that throws out traditional use based zoning and focuses on urban form and the creation of a high quality public realm. Although the approach is new, the code promotes the development and redevelopment of a traditional downtown environment. The draft is based on public workshop sessions and is ready for additional comments and direction.
- Transportation Center- The City Planner and Eric Cousens attended a meeting at of the project team (ATRC, Casco Bay Engineers, Harriman Architects and Platz Associates) on Wed. January 28. Doug Greene, Eric Cousens and Alan Manoian met with Platz Associates to discuss the integration of the Transportation Center with the proposed parking garage in Great Falls Plaza and the future lotting of that area.
- City Planner is coordinating the Staff review of the following Projects
 - Falcon Creek Condominiums- Change from condominium regime to a planned unit development and downsizing of project.
 - o Good Shepherd Food Bank- Expansion of Cooler
 - o Crystal Springs Bottling- Paving and driveway expansion for a new business.
 - Lot split for former TGIF restaurant to facilitate new tenant.
- City Planner will present 3 items at the February 9 City Council meeting. These items were moved from the February 2 meeting due to a storm cancellation.
 - New Auburn presentation This is an update on what has taken place so far and what is planned in the short and longer term. Another focus of the presentation will be requesting CIP funding for the design of the planned Riverway Road and its coordination with the adjacent Greenway design.
 - 2nd Reading and Public Hearing on Planning Board Ordinance- Staff prepared memo submitting research on legal "standing").

- o 2nd Reading and Public Hearing on Land Use Change at 113 Woodbury Road.
- The Barker Mill Dam relicensing process was supposed to include a study plan delivered in the month of January. The consultant is behind schedule but they have told us that the plan is coming soon. Police

- > The department handled 761 calls for service this week.
- > Officers conducted 128 motor vehicle stops and 21 field interviews.
- Officers investigated 76 offenses of which, 4 of which were felonies, generating 21 arrests, 31 criminal summonses and 1 juvenile arrest.
- > Officers responded to 105 motor vehicle crashes.

Recreation

- Youth Indoor Soccer, ages 4-7 continued. In this six week program, players will be introduced to the basic techniques of soccer in a fun and positive environment. Emphasis will be on learning through fun games and small-sided play. Other skills such as communication and sportsmanship will also be incorporated. Currently, a total of 46 players are registered for the program.

- Pickleball has continued to be a big hit as week 18 of the program continued. Pickleball is a tennis-styled sport that is played on a badminton sized court indoors or outdoors. The "Pickleball" is a plastic ball with holes that is served, volleyed, and rallied back and forth over a net using a wooden paddle. As of Thursday, there have been 300 participants, with new members coming in each day of the program. Pickleball will take place every Tuesday and Thursday, 9:00am-11:00am in the Hasty Community Center Gymnasium. The fee is \$2.00 for Auburn Residents and \$3.00 for Non-Residents.
- Youth open gym continued. This free after school program is for Auburn students and runs Monday-Friday from 2:30 – 4:15 PM.
