Assessing

- > Staff is preparing for the personal property canvas and mailing.
- ➤ Katelyn has been working on sending letters and scheduling appointments for outstanding building permits.
- > Joe's Permit inspections are ongoing.
- ➤ We will now be linking deeds and DOV's to the property record cards. Joe has linked all the October declarations of value.
- ➤ Karen had a tax appeal hearing with the Board of Assessment Review for Prospect Hill Golf Course. A second time is being scheduled to complete the hearing.
- ➤ The abatement deadline has passed. Karen has 7 abatement applications to review.

City Clerk

- Received 3 business license renewal applications and 1 new business license application.
- ➤ Issued 3 business licenses (renewals)
- Received and completed work on approximately 150 new voter registration and name/address change notifications from the Secretary of State's office
- ➤ Issued 1 taxi cab license
- Filed approximately 200 cancelled voter registration cards
- ➤ Issued 1 birth certificate, 31 death certificates, 4 marriage certificates, 3 marriage licenses, and 6 burial permits

Community Development

- Reine Mynahan met with Chief Crowell and Holly Lasagna, Bates College, to talk about the inclusion of Bates students in the study process for service needs of at-risk youth. The work should be under way in the next few weeks.
- Reine Mynahan attended a meeting of New Auburn United to introduce Auburn's consultant, St. Mary's Nutrition Center, and the concept of community gardening. This was the first effort at trying to gauge neighborhood interest in community gardening.
- ➤ Hal Barter and Reine Mynahan met with Community Development staff from City of Lewiston to update them on the process of uploading data collected during the Healthy Homes inspection, and to talk about equipment requirements. The Lead Hazard Control Grant will pay for the purchase of a tablet.

February 26 was the deadline for receiving proposals for social services. A committee of 7 will be reviewing the proposals this weekend and scoring them. The committee will then meet next week to make their final selections.

Fire

- > FPO O'Connell performed site visits to several occupancies as part of either new constructions or remodeling
- FPO O'Connell had to testify in court regarding a squatter in a building which was deemed unsafe for habitation. This involved another issue involving the squatter.
- Fire units responded to a small fire at Sherwood Heights School. Damage was limited and there no injuries.
- AFD administration met with Auburn School officials for a debriefing on the recent fire at Sherwood Heights School. Additional working agreements were developed between these two organizations.
- Crews continued refresher training on Hazardous Materials Operations level training and CPR recertification, a program taught by internal instructors.
- For the week of February 19th to February 25th, we responded to 94 calls for service. These include, but are not limited to: 7 fire alarm call, 1 fire call (Sherwood Heights), 58 Emergency Medical calls, 12 Motor Vehicle Accidents, 9 with injuries, 10 service calls and 5 Hazardous Condition calls. We provided no mutual aid assistance and received one mutual aid during this period. We also provided 1 EMS Mutual Aid call.

Health and Social Services

- ➤ On Monday I attended a Maine Welfare Director's meeting in Augusta. Our guests were Jonathan LaBonte Governors office, Bethany Hamm DHHS, Chase Martin Esq, Policy Advisor. We discussed the shift in cost to the municipalities when the State no longer allows certain class of people to receive State benefits. This puts a burden on the General Assistance program for their basic needs. The Governor's proposed budget and informed them we were against the new municipal reimbursement schedule.
- Our secured wall should be completed on Friday; this will be a great advantage to our office.

Human Resources

- The vacancy for Assessing Assistant was posted this week. This follows the City Council approval of the Ordinance merging the Assessing functions with the Financial Services Department.
- Ray Lussier, Safety Coordinator, participated in an after incident debriefing meeting following the evacuation of Sherwood Heights School last week as a result of a fire. Representatives of the School Department, Police Department and Fire Department attended. Issues identified will be addressed in the Emergency Evacuation Plan.

ICT

- Department Manager Renee Bogart has resigned her position to pursue other endeavors. We wish her the best of luck in the future. The Department will continue operations with existing staff in the near-term, and will re-evaluate staffing levels going forward.
- Completed final draft of GIS Protocol, using new, updated user roles and presented it to the GIS Steering Committee. The roles now match roles used by MapAuburn. The GIS Protocol is scheduled to be presented to staff at the next Manager's meeting.

- Updated and created a new set of geo-database features that integrate our snowplowing routes and our sidewalk plowing routes, based on the districts defined by Public Services. We are still working with Public Services staff to create a map or map book that will best show this newly related data.
- Made changes to the Marriage License form provided by the State. The form fields, as designed, didn't provide sufficient space to list full names in cases where the names are very long.
- ➤ Updated our new MapAuburn viewers to include links (along the top) to the City of Auburn website and to the MapAuburn Home Page.
- ➤ Provided an updated set of GIS data for utilities (Water, Sewer, Stormwater) to consultant for use in MS4 compliance efforts.
- Staff deployed two digital displays in the Auburn Hall lobbies. These two were a proof-of-concept, and we should be able to roll out others if the need is there. Essentially, it's a laptop in a cupboard running a MS Powerpoint presentation. Rosemary Mosher designed the slides to incorporate elements from the City's website, and built templates so that the Clerk's Office staff will be able to easily update and extend the information displayed.
- > Staff worked with Assessing and the support team at Patriot Properties after a minor navigational error caused some of the Personal Property data to display incorrectly.
- ➤ Staff met with Safety Coordinator Ray Lussier and staff from the 911 CommCenter, Fire and Police, as well as with MIS staff from Lewiston to discuss some concerns and policies with responding to 911 Emergency calls.

Police

- The department handled 734 calls for service this week.
- ➤ Officers conducted 195 motor vehicle stops and 15 field interviews.
- ➤ Officers investigated 78 offenses of which, 5 of which were felonies, generating 16 arrests, 26 criminal summonses and 2 juvenile arrests.
- ➤ Officers responded to 47 motor vehicle crashes.

- ➤ Snow picking continues to relieve congestion on our priority 3 residential streets, Pleasant, Elm, Spring, Hampshire, Webster, Goss and Winter Streets.
- Mail box repair work orders are coming in at a steady pace and being handled by DJ Sjostrom our carpenter.
- Second shift Ed Nemethy and Brian Lothrop continue to alleviate sight issues at problem intersections.
- > The tool crib master Walter Reynolds is finishing up winter preventive maintenance on small equipment.
- Facilities tech Mike Reed continues being the best he can be by giving us all a clean and safe place to work.

Recreation

- ➤ Registrations opened for Recess Warriors, ages 4-7. Recess Warriors is a five week program that will consist of a new activity each week and will allow children to take part in a variety of games. Activities will range from a classic game such as soccer, to a playground favorite like capture the flag.
- Registrations continued for Youth Lacrosse, grades 3-8. Lacrosse has become one of the fastest growing sports in the nation, and teams can be found at the professional, collegiate, high school, and recreation levels all around the country. Players will be introduced to skills, drills, techniques, and rules of the game, in addition to a regular practice schedule and full game schedule beginning in late April.
- Registrations continued for Adult Dodgeball and the regular season will begin on Sunday. The fast-paced and action-packed game of dodgeball is back! Teams will participate in a 6 week regular season, culminating with a single elimination playoff tournament. A total of 6 teams are registered in the league this season. Approximately 60 players participate in this league.
- Adult Men's playoff basketball games continued. The Men's A division championship game is scheduled for Sunday where TJ's place will square off against JC Services. A total of 24 teams are registered in the league this season. Approximately 288 players participate in this league.
- Adult Women's playoff basketball games continued. A total of 6 teams are registered in the league this season. Approximately 72 players participate in this league.
- ➤ Pickleball continued into week 21 of the program. Pickleball is a tennis-styled sport that is played on a badminton sized court indoors or outdoors. The "Pickleball" is a plastic ball with holes that is served, volleyed, and rallied back and forth over a net using a wooden paddle. As of Thursday, there have been 320 participants, with new members coming in each day of the program. Pickleball will take place every Tuesday and Thursday, 9:00am-

- 11:00am in the Hasty Community Center Gymnasium. The fee is \$2.00 for Auburn Residents and \$3.00 for Non-Residents.
- ➤ Youth open gym continued. This free after school program is for Auburn students and runs Monday-Friday from 2:30 4:15 PM.
