- Nomination papers for the 2 vacant School Committee seats became available on February 9th. Two individuals have taken out papers.

Community Development

- Yvette Bouttenot is working 2 potential homebuyers who are interested in purchasing a share in Raise-Op, a cooperative housing development in Lewiston. A share means they will have control of the apartment they live in and will build equity. The building will be undergoing rehabilitation and lead remediation with funding from Coastal Enterprises and the City of Lewiston. The applicants have enrolled in the HOME Savings Account to prepare for the down payment for their share. The City of Lewiston will match their savings 2:1. The City of Auburn administers the Homebuyer Program for the HOME Consortium whereby we provide services to process applications as well as credit and debt counseling for the clients.
- The Citizens Advisory Committee reconsidered the goals and strategies for the 5-year Consolidated Plan—the document which sets the priorities for spending Community Development and HOME funds. They recommended several changes. These changes will be incorporated into a new document to be voted on via email. This was the final meeting for development of the Consolidated Plan. The Citizens Advisory Committee will meet again in a few weeks to review the annual budget.

- The Community Development Loan Committee approved an \$18,000 application to address safety issues. The couple lives on Social Security benefits and one of the owners will soon be restricted to a wheel chair. Renovations include several adaptations that will allow the wife to remain in her home rather than enter a nursing home. The benefits to this project are not only addressing the needs of this household, but also savings to taxpayers.
- ➤ Hal Barter attended a 2-day training to prepare for the role he will play in implementation of the Lead Hazard Control Grant for both Auburn and Lewiston. The training was the first step in Hal being certified to conduct the 29-point Healthy Homes Rating System inspection on units being considered for a lead grant. The 29-point inspection is a new initiative that is mandated by HUD for all lead grants, and it appears this type of inspection will be required for all rehab projects in the future.
- ➤ Hal Barter conducted an initial inspection of a City of Lewiston property under the Homeowner Rehab Program. Auburn Community Development will be providing the staffing for all Homebuyer and Homeowner Rehab Program projects for both cities. Through the inspection Hal has identified all improvements that must be done to meet the Auburn Consortium's Housing Standards.
- The Community Development and HOME allocations have been released by the Department of Housing and Urban Development. This year's allocations are reduced from last year, although they are a less significant drop than in the past few years. The Community Development grant for FY2015 is \$521,295 compared to \$530,912 in FY2014, and a HOME grant of \$332,327 compared to \$364,163 in FY2014.
- Reine Mynahan met with Planning Decisions consultants Frank O'Hara and Sarah Curran and Lincoln Jeffers, City of Lewiston, to wrap up with changes to the draft Consolidated Plan. There are many strategies where the cities share a common direction. Since the City of Auburn is the lead agency in the HOME Consortium, Auburn's Consolidated Plan will incorporate the entire document for Community Development funding strategies for the City of Lewiston.

Tax Office:

The focus this week has been continuing work on outstanding personal property taxes. Staff has been gathering contact information, making phone calls, etc to determine if the businesses still exist and working on payment arrangements to clear up delinquent taxes.

Fire

- FPO O'Connell investigated an unsafe living condition situation which one of our crews discovered while on a call the previous evening. As a result, the building which had no appropriate services had to be plaque carded and the department assisted the occupant with relocating.
- Engine 5 station hosted visits from the Temple Shalom preschool, providing an educational program of fire safety for children.
- The department was very busy with calls as a result of the several snow events this past week.
- > FPO O'Connell performed an occupancy inspection for several local businesses.
- FPO O'Connell completed the final inspection for the new Café at the airport.
- Deputy Allen represented the Fire Department at the dedication of the memorials for the victims of the Lacoste Nursery fire which occurred 70 years ago. Cub Scout Pack 111 did an excellent job of acquiring appropriate memorial stones for all the unmarked graves of the

- victims. DC Allen gave a presentation of how this and other tragedies have brought about change to provide for the safety of our citizens.
- ➤ Crews continued refresher training on Hazardous Materials Operations level training and CPR recertification, a program taught by internal instructors.
- For the week of February 5th to February 11th, we responded to 114 calls for service. These include, but are not limited to: 6 fire alarm call, 3 fire calls, one cooking, 2 chimney fires, 77 Emergency Medical calls, 13 Motor Vehicle Accidents, 9 with injuries, 9service calls and 6 Hazardous Condition calls, and 1 RIT call to Lewiston. We provided 1 mutual aid assistance and received no mutual aids during this period. We also provided 1 EMS Mutual Aid call to Turner during this period.
- ➤ FPO O'Connell investigated a possible illegal basement apartment. Investigation revealed it was illegal, situation being handled by FPO and Code Enforcement.
- Rescue 5 and Truck 1, along with 315, responded to a work place accident at the Auburn Mall. A worker fell through a skylight in the roof and was critically injured. APD and OSHA are conducting an investigation.
- > Crews attended training this week on rope rescue operations.
- ➤ DC Allen attended a meeting to discuss interoperability of our radio systems.
- ➤ DC Allen met with Derek Boulanger and engineers to discuss the testing of repair options for the Central Station floor issue.
- ➤ Crews continued refresher training on Hazardous Materials Operations level training and CPR recertification, a program taught by internal instructors.
- For the week of February 12th to February 18th, we responded to 92 calls for service. These include, but are not limited to: 8 fire alarm call, 1 fire call (chimney fire), 52 Emergency Medical calls, 11 Motor Vehicle Accidents, 7 with injuries, 11 service calls and 9 Hazardous Condition calls. We provided no mutual aid assistance and received no mutual aids during this period. We also provided 2 EMS Mutual Aid calls.

Health and Social Services

- We are seeing an increase in Able Bodied Adults without Dependents (ABAWD) applying for food assistance. They lost their SNAP benefits in January and one trip a month to the food pantry is not sufficient to meet their daily needs. ABAWDs that lost their SNAP benefits can regain them on a month to month basis if they volunteer (about 26 hours a month) for a nonprofit or for-profit organization, do workfare or work at a job at least 20 hours a week.
- ➤ I went to Westbrook on Friday to teach a GA basic class put on by MWDA to a number of new GA administrators.
- ➤ Community Cords YTD expenditures so far, \$3413.00 we still have a few more weeks of heating to put up with.
- ➤ Construction has started this week in our waiting area; this will give clients more privacy when talking about confidential things and will also provide staff with security in the event a disorderly individual wants to come in.

Human Resources

➤ The deadline closed for recruitment for Firefighter/Paramedics. The City received 28 applications. The HR Department is working with Deputy Chief Allen to coordinate the physical agility test.

- ➤ Charles Toomey, currently a Parks Maintenance Worker has been promoted to Equipment Operator. Charles has a been working closely with the Public Services operations since the merger of the Parks Maintenance Division and has a Commercial Driver's License (CDL) required to operate the equipment.
- Stuart Cushman was hired as a Parks Maintenance Worker to replace Charles Toomey. Stuart has 10 of years experience at the Portland Public Works Department.
- ➤ Deb Grimmig attended a Human Resources Group meeting in Freeport. Ann Charles of MMA Wellness Works presented information on implementing and maintaining effective employee wellness programs.

ICT

- Spent the better part of three days attempting to solve a problem with GIS data downloaded from MapAuburn. Early in our mobile data collection efforts we experienced a file lock on our mobile devices that required assistance from the software company. Last week we discovered an additional problem, buried in the data structure. We were able to correct the problem and restore the data.
- > Created a new Staff version of the MapAuburn Parcel viewer that provides additional search and selection criteria, as well as includes additional map layers. Three users are testing the site and the documentation. We hope to roll the new viewer out to everyone soon.
- Participated in a conference call to define the parameters for a map for inclusion on public kiosks. The kiosks will be located in both Auburn and Lewiston, so will require a single, seamless map. While we are still working to determine the final specifications, both cities agreed to use the same cartography used in our MapAuburn basemap. We have provided Lewiston with a template so that they can verify their data configuration.
- Fulfilled a request by Auburn PD to determine the census block group and tract designations for two lists of addresses. GIS analysis allowed us to programmatically determine the information for the entire list, rather than look up each address individually.
- Created draft maps of the Airport to the Airport Manager and Event Planner area for event planning.
- > Staff participated in the Discovery phase of the Tyler Content Management project with Finance staff and the implementer from MUNIS. When complete, this will provide a quite robust document management solution.
- ➤ We are working with Cardinal Tracking to resolve some issues in the parking ticket management program.
- Staff engineered, and procured the components for, the electronic display board project for Auburn Hall. We will be using some concepts from the Norway Savings Bank Arena (thank you, Jason Paquin!) to replace the plastic letter boards with a more attractive solution that will also be easier to update/maintain.
- This week the Switchboard alerted us to a potential problem with our phones and the Emergency 911 system. It appears that some phone extensions may not be reporting the correct address to the 911 dispatchers. For example, a phone that was moved from Auburn Hall to Public Services still sends a location address of 60 Court Street, and a phone that moved from Pettingill Park to the NSB Ice Arena is still sending its old address. Many of our newer extensions seem to be reporting as 60 Court St, even if they're located at other buildings. It has been several years since we'd gotten everything straightened out, and it seems that some of our location changes are not being reflected in the outgoing call data. We'll be working with Ray Lussier, Oxford Networks, New England Communication and

- the CommCenter to figure what happened and how to fix it. We will also be addressing what role our Auburn Hall Switchboard Operator should have when a 911 call is made.
- All the components for the Lobby displays have arrived, and we should have those mounted and configured by the end of next week. The Electrical Division provided outlets at both locations, and Rick Duchesneau has mounted the swivel arms.
- Revised the GIS Protocol document based on feedback from staff who are currently working with GIS. The revisions will incorporate user roles defined within MapAuburn. The protocol will be presented to the GIS Steering Committee for final approval, and rolled out to staff in the coming weeks.
- Worked on revisions to geodatabase of Culvert data (including photos) collected by Public Works Staff. This was our first attempt at using tablets for a full data collection. The effort was successful by nearly all accounts, but due to a glitch that has since been solved for future efforts, the photos for the first collection cannot be easily related to the data records. We are working on better understanding the process and developing a solution.
- ➤ Working with Public Services, staff began putting together a new system for categorizing and mapping our sidewalk plow routes that will integrate with the current plow routes.

Planning

- ➤ Cavu Café, was issued a restaurant license on February 10, 2015 and had a soft opening on February 11, 2015. Chef Molly Hill said in a Sun Journal Article that she hopes to challenge Auburn's palate a bit, offering her twists on comfort food: an albacore and Swiss cheese tuna melt or macaroni and cheese made with curly noodles and Gouda cheese.
- The Board of Appeals will meet on March 19 for a workshop regarding the ordinance that established the Board and their policies and procedures. Similar to the Planning Board, I suspect that they will ask the Council to amend the ordinance to promote membership, public involvement and any other concerns identified by the Board. It can be a major challenge to find people willing to volunteer to serve important functions like those of the Board of Appeals and because of their infrequent meetings and extensive learning curve for the variety of duties, staff hopes the Board will recommend either longer terms or to allow members in good standing to be reappointed as many times as the Council decides that they should be.
- Form Based Code- The draft Form Based Code is now being reviewed by the Planning Board and Staff. The Planning Board had their first review of the draft on Tuesday, February 10 and will reconvene at a workshop on Monday, February 23rd. This is an implementation item in the Comprehensive Plan.
- New Auburn- Eric Cousens and Doug Greene made a presentation to the City Council on February 9th regarding the final adoption of the New Auburn Village Center Plan and to request funding for the design of the planned Riverway Road and its coordination with the adjacent Greenway design. The Council will be asked to act on the requests on February 17th. This is an implementation item in the Comprehensive Plan.
- ➤ The City Planner is preparing sketch designs for the Minot Avenue gateway entrance into downtown. This is an implementation item in the Comprehensive Plan.
- Doug and the Planning Board are working on a Text Amendment to create a new zone that will allow multi-family development in a suburban setting. This is an implementation item in the Comprehensive Plan and will accommodate market demand that we are aware of for this type of housing.

- ➤ The City Planner attended a meeting with City Staff and Edward Little High School officials to discuss ways for students to help in actual city projects.
- The City Planner will meet with the director of Maine's AARP Aging in Place program to discuss potential for Auburn's participation. This relates to an implementation item in the Comprehensive Plan.

Police

- ➤ The department handled 1,384 calls for service during this time period.
- ➤ Officers conducted 371 motor vehicle stops and 66 field interviews.
- ➤ Officers investigated 139 offenses of which, 10 of which were felonies, generating 34 arrests, 44 criminal summonses and 7 juvenile arrests.
- ➤ Officers responded to 133 motor vehicle crashes.
