Assessing

- There have been several sales of property on Taylor Pond over the last three years. The majority of the sales of year round homes have sold more than 20% over the assessed values. Therefore we have begun tracking the sales on the Pond for a sales ratio study. This will help us determine if there is evidence to support a possible increase in values in the next couple of years. There must be a significant amount of arms length sales over a period of time in order to have enough data to perform a sales ratio study. Sales Ratio studies are an important tool used to maintain equity throughout different classes of properties and the city as a whole.
- August deeds and declarations have been loaded and staff is currently working on September.
- Permits issued October thru December are being loaded in the Patriot CAMA system. When permits are issued the paperwork is given to the Assessing Department to be reviewed and loaded in the CAMA system for future inspections.
- The deadline for filing the paperwork to the State for the BETR reimbursement is December 31st. All applications received by this office have been processed and returned to the businesses.
- One alternate member's term on the Board of Assessment Review ends in January and due to other commitments will not be serving another term. This leaves four full members on the Board. A full Board consists of five members and three alternates. The openings have been posted.

Auburn Public Library

- The Library is closing at 1:00 PM on Saturday, December 31, and will be closed on Monday, January 2, for the New Year holiday. We wish everyone a very happy 2017.
- The Library recently received a \$500 grant from Norway Savings Bank to be used to support technology or a program need.
- The Library has been awarded a PLACE grant from The Califa Library Group, a non- profit membership cooperative serving libraries and information organizations in California and the rest of the country. In partnership with the National Oceanic and Atmospheric Administration (NOAA) the Library will provide programming to help our community build resilience by increasing their environmental literacy. The Library will take part in

professional development activities to expand our understanding of the emerging role of libraries as a center for promoting environmental literacy and community engagement around climate change issues. We will conduct a series of programs based on a book discussion format with a NOAA scientist as a co-facilitator and complete periodic online evaluation surveys. There is a \$1,000 stipend with this grant to support book discussion materials/program expenses and purchases for our collection. This grant will dovetail quite well with our Maine State Library/Cornerstones of Science grant activities.

- The Library at the beginning of the month sent out annual fund reminders to supporters. The response has been very good.

Fire

- > Crews responded to 3 fire calls during this time, including 1 structure fire.

- Crews responded to a large gasoline spill when a truck hit a fuel pump and cracked the piping.
- > Staff performed a tour of Central Station for a disabled child.
- > Staff attended meetings on the proposed Senior Center.
- > Crews attended training on Pediatric Medical Emergencies.
- > Crews participated in the annual AFD Truck Load of Christmas program.
- > Staff met with an insurance representative from last week's fire.
- > Staff and Crews performed 3 inspections.
- For the week of December 22nd to December 28th, we responded to 91 calls for service. These include, but are not limited to: 3 fire calls, 56 Emergency Medical calls, 7 Motor Vehicle Accidents - 4 with injuries, 3 Hazardous Condition calls, 14 Service calls, and 7 fire alarm calls. We received 0 mutual aid responses during this period and we provided 0 mutual aid responses. We provided 1 Paramedic intercept during this time.

IT

GFTV staff continued work on the studio and did some holiday programming, focusing on shows for the Christmas season. The studio is coming along nicely and all of the electrical work has been completed. Staff are now configuring the cabling and lighting as Weekly Report

well as setting up the production equipment. We also continue our regular duties with editing, the community bulletin board and programming.

- IT staff spent the better part of a day this week troubleshooting an intermittent problem with a computer in the Tax office. Problems in the Tax office generally present with a particular urgency, due to the front-facing nature of their jobs. In addition, many of the state programs used by the Tax clerks have very specific program requirements that can be updated inadvertently creating conflicts with other programs. After a number of hours chasing rabbits down rabbit holes, we discovered a Microsoft security update had run the night before. This update was to a security program that we don't generally use, and was likely accidentally installed as part of a routine Windows update (when installing the Windows update the user may not have scrolled down to the bottom of the User License page, read all of the fine print, clicked the special options button, and unchecked the option that allows the software to automatically install these annoying programs!). When we uninstalled the program, the problem went away.
