### **Assessing**

- > Staff has been working on updating new parcels in the CAMA system created from splits and merges of properties. When deeds are received they are reviewed for splits and merges. Any properties that have been split from or merged with another property are forwarded to Gary J. He reviews the deed, creates the parcel, sends the information to the Assessing Department to update the CAMA system and forwards the same information to the IT department so GIS maps can be updated.
- There is a parcel located in Auburn owned by the Town of New Gloucester who purchased the property from the State of Maine in 1988. The parcel is currently tax exempt. Staff is researching the reason the exemption was granted and whether the property currently qualifies for tax exempt status. It appears from the GIS aerial photos the parcel is vacant. Staff will inspect the property and reach out to New Gloucester to verify the use of the parcel. The Maine Revenue has confirmed it does not qualify unless it is being used for municipal purposes.
- > Research on communications towers continues. Staff inspected one tower site this week and confirmed ownership and contact information. Inspections of all sites will be done as weather permits.
- > Permit inspections continue.
- > One staff member took her Certified Maine Assessor exam on Wednesday.
- ➤ The personal property depreciation tables are rolled to the current year after the abatement deadline passes. The tables were rolled on Tuesday. As a result of updating the depreciation tables the personal property valuation dropped over 9 million dollars. In addition to the 9 million dollar loss, the closing of Cascades Auburn Fiber resulted in a loss of 6.9 million in valuation of personal property.
- ➤ Staff has begun updating the 2017 personal property forms in anticipation of the March Form 706 mailing to all business owners. A public notice done every year with the City of Lewiston addressing the Form 706 will be posted in the paper and the first canvas of businesses in the city will be next week. An announcement of the canvas will be posted on the Auburn website on the Assessing page. The canvas is done to gather the information to update our list of businesses in the database for the mailing. We will do a second canvas in late March to add additional new businesses and remove closed businesses (as of April 1) from the list. Last year we had 1063 personal property accounts.

## **Auburn Public Library**

- ➤ The staff meeting on Weds., 2/8, was rescheduled due to inclement weather. The Library had a two-hour delayed opening that day and closed at Noon on Thurs., 2/9, due to the storm.
- ➤ The Teen Librarian spent Fri., 2/3, at ELHS. She visited two freshman and one sophomore English classes, using the time to share information about the Library, our website resources, and many of the teen programs. She also discussed future collaborations with the EL librarian, including a joint teen advisory board and bringing 9<sup>th</sup> graders in for Fall tours.
- The Board of Trustees will hold its regular monthly meeting at 7:30 a.m. on Weds., 2/15.
- ➤ The Library will make its regular monthly visit to Minot's town hall on Thurs., 2/16, from 4-6 p.m.

The retention period for the absentee envelopes is two years, the incoming voter list is five years, and all other materials can be destroyed after 22 months.

## **Economic and Community Development**

- > Staff and the Parks Department met with a candidate for a new part time Farmer's Market Coordinator to discuss setting up a Farmer's Market in New Auburn, tentatively planned for Tuesday's this summer from 4 to 7 pm.
- Transferred over 85 scanned HHE-200's to the "U" drive for identification since last Thursday-We are well on our way to making them available online for the entire Lake Auburn Watershed.

- ➤ 22 permits were applied for this week; 4-Commercial bldg, 1-Residential bldg, 8-Electrical, 7-Excavation & 2-Plumbing
- ➤ February 4, 2017 -Last Saturday night approx. 9 PM Cristy Bourget responded to a grease fire on the stove at Margaritas. Margaritas decided to close for the day to get the extra cleaning done and for employees to watch the Super Bowl. Cristy did not want them to have a loss in sales on Sunday so she reinspected that day. This timely service is a great benefit to having a local inspector.
- > February 8, 2017 Taco Bell held its grand opening.
- ➤ A Home Occupation Permit and Business Food License was approved for Hum-Dingah! Hum-Dingah is operated by Patrice Currie and is located at 223 Cook St. The business will be baking brownies and will sell them off the premises.
- Several letters have been sent to a downtown commercial establishment regarding our noise ordinance and a dumpster company which empties the dumpster at 2:30 in the morning. This week a Notice of Violation was sent to the commercial business and citations will follow if they continue to wake the neighbors at night.
- There were several plan reviews done within the past week, to include the Senior Center at Pettengill, the conversion of the Spurwink School on Danville Corner Road to add a 15 bed residential care facility, and a remodel and addition to the Precision Machining Technology wing at CMCC.
- An Investigation of an unlicensed sign installer at local lumber company was completed. The signs that were being installed are unsafe and have bogus UL labels. A Lumber Co. representative was notified and was appreciative for the cities work in protecting their investment in getting the safe and long lasting sign that they paid for.
- > Investigated water damage to electrical infrastructure at 25 spring st with AFD.
- > Inspected a dryer fire on Millet Dr. The fire was caused by an improperly installed electrical cord and utilizing a residential washer / dryer combo for commercial business.
- ➤ Inspected three new medical marijuana grow facilities and reviewed plans for marijuana extraction equipment at a licensed grow facility
- > Staff met with representatives of a current Auburn Business that recently purchased property to expand their business; this could create up to twenty new jobs and over a million dollars in taxable value.
- > Staff met with representatives of Savage Services Corporation to discuss a proposed expansion.
- > Staff continues to work with a current Auburn Business looking to purchase property to expand their business; this could create up to five new jobs and \$500,000.00 in taxable value.
- ➤ The 2nd Quarter Financial Report was submitted to HUD and the program income receipts for October January were reconciled in GMS.
- ➤ The CDBG Loan Committee approved loans for 2 CDBG projects for a total of \$27,019.00.
- > Updated By-Laws for the CDBG Loan Committee were adopted at the February Meeting.
- Staff did a presentation at the Economic Development Round Table on the STAR and Neighborhood Challenge Grant Programs.
- > Staff is preparing for the initial meeting of the Citizen Advisory Committee and Sub-Committee for development of the CDBG/HOME budget.

- > Staff addressed multiple code issues with a landlord of large multi-unit apartment that was about to have water shut-off. Staff's work may have kept 21 families in their homes.
- Addressed other code complaints such as dumpster overflowing, unauthorized automobile graveyard, no/low heat calls, and non-permitted uses of a property.
- ➤ A pre-bid meeting was held for Boba, however this project will not be ready for the March Loan Committee as there has been a delay with the designer with some final revisions.
- A pre-bid meeting was held for 46 Fourth St. this project will be presented to the March Loan Committee.
- ➤ Staff conducted HHRS (Healthy Homes Rating System) inspections and reports for 4 units, 2 initial inspections for the Star program and Rehab programs and 2 inspections concerning warranty issues on previously funded work.

### Fire

- Crews responded to 6 fire calls during this time period, including a house fire on Old Danville Road.
- > Crews attended class for annual CPR refresher training and certification.
- Staff also performed several other follow up inspections, C/O inspections and plans reviews.
- > Staff did 2 fire investigations.
- Staff investigated several critical Life Safety issues in apartment buildings.
- Crews attended monthly Blood Pressure Clinics at AHA buildings.
- > Crews attend training on breathing air management for the fire service.
- ➤ The EMS Training Team held a meeting for new members.
- > Staff did a site visit to meet with developers for the re-purposing of the Cascades Fiber Building to discuss Fire Protection and Life Safety needs.
- Staff met with representatives of Savage Safe Handling to discuss future expansion plans.
- > Annual ground ladder testing was completed this week.
- > Crews performed 13 inspections, 0 of which were for licenses.
- For the week of February 2<sup>nd</sup> to February 8<sup>th</sup>, we responded to 79 calls for service. These include, but are not limited to: 6 fire calls, including a house fire, 57 Emergency Medical calls, 6 Motor Vehicle Accidents 3 with injuries, 3 Hazardous Condition calls, 1 Service call, and 1 fire alarm call. We received 1 mutual aid response during this period and we provided 0 mutual aid responses. We provided 5 Paramedic intercepts during this time.

#### IT

- This week was a typical week for GFTV, but with the weather hampering some of our efforts. A meeting to train E.L.H.S. staff was cancelled due to storm. Staff covered meetings and worked on programming. We also worked on policies for the new studio. Weekly tasks involve working on the community bulletin board, file encoding and other file prep.
- Staff met with Randy Visser from Tightrope Media. Randy was instrumental in developing PEG TV

- in Maine and also worked to establish CTAM., The Community Television Association of Maine.
- ➤ This week, GIS staff began testing a new procedure for updating State of Maine's E911 address point database. After testing an update system several months ago, the state decided to pursue a different method for updates. We have completed a round of test updates and are waiting for word from the state to proceed. The new update method allows us to use ArcGIS Pro (the new GIS desktop software) to link directly to a published feature class to make our edits. Previous methods, involving file transfers, were cumbersome and fraught with problems. Auburn is the first user to test the new State process. So far, the new method appears to be working with no difficulties.
- Dozens of problems are submitted by staff to the helpdesk each week. Most of these are not noteworthy for a weekly report, but together they can eat up countless hours of precious IT time. Sometimes a particularly niggling problem occurs, spanning days or sometimes weeks, evading solution by the brightest minds in the organization and beyond, and causing widespread head-scratching, frustration, and on extremely rare occasions, the blasphemous condemnation of all things IT. Fortunately, we tenaciously persevere and leave no problem unsolved. This week UT staff solved the 'empty sentemail folder conundrum' reported by an Auburn Hall employee. As is often the case, a problem that evaded us to distraction had a simple solution ...when viewed in hindsight. We removed a roque filter and all was good with the world.
- As part of an ongoing effort to determine how to improve the use of Energov, IT staff and a City of Auburn IT consultant participated in a conference call with Energov. The purpose was to get recommendations from Tyler (the owners of Energov) for the best way to address needed upgrades as well as options and cost estimates for reviewing/reimplementing workflows, file setup review, and clarification of the modules we own. With the help of Lewiston IT and Energov tech support we now have a reasonable specifications for replacing and upgrading this server and software. We are still waiting for additional information from Energov/Tyler before the consultant can put together a complete recommendation.

#### Police
