

I was repeatedly told this was a low priority, I had no proof and it probably won't go anywhere, as with the DA. I was told to wait because he has "more important crimes" to deal with... weeks passed... the patrolman told me he went to the house of the perpetuator (after I did all the work and investigation and tracked her down) and he told me she was not home and he left his card at her house. I had to "be patient" and when he had time he would bring her in for me to identify. I waited several weeks... was then told he was on leave. I waited 3 more months - all this time feeling unsafe in my home because she new where I lived and had access to all my personal information. (1) she worked at the same hospital and had access to my records (2) she used another police officer to run my plates. This other police officer I just happened to know is a great guy, a good cop (who did a stupid thing) and so I did not file a complaint about him. I also did not file a complaint on the primary cop because after close to 5 months, I just wanted it over. Eventually, I filled out a form at the department requesting that he call me within 24 hrs as I had just about had it with waiting and being told this crime was not important. He did call, said he "forgot" all about my assault etc and he promised to follow-up with the perp. I never heard back if he did follow-up or not. But I did tell him if the perp and I meet again, it would not end well. Now, when I see people in the paper going to court for having a dog unleashed, it annoys me to no end. There seems to be time for minuscule offenses, but no time to investigate a psychotic woman who went ballistic on me, my dogs and my vehicle, and threatened to kill me, and stalked me showing up at my house. It made my life hell. No. I don't want the Chief to follow-up. Pretty done with that. Thank you for listening. BTW, I have no record and have always obeyed the law. As a daughter of a highly respected Lewiston police detective (now deceased). I would never let him down by breaking any law. This was my first time filing a complaint with a police department. I am so disappointed. It really failed me in so many ways.
