1. Approval of Minutes

2. Sub Committee Report – Senior Sub Committee (Belinda)

Belinda provided an update on fundraising attempts with the Senior Sub Committee. There was interest in providing a bottle drive at Roopers. There was a mention about having Auburn residency to be placed on the next meeting agenda. The Beach was also mentioned and clarification around the testing of the water, this will also be placed on the next



meeting agenda. There was concern around Community Programs and why some line items were listed under recreation. There was a suggestion for adding an Arts and Culture line item to help with any new events that may pop up. The Special Revenue section reflects actual hard numbers rather than projected numbers. There was concern on this report showing revenue and no clarification on the revenues going back to the general fund.

Action Item: Everyone take a look at the Community Programs and email Sabrina with concerns for the next meeting.

Staff Schedule – Recreation will now have two recreation specialists that are being moved from salary to hourly employees. This will create the opportunity for Overtime pay during special event and programs.
