I am writing to formally introduce myself and share a summary of my professional background, skills, and continuing career aspirations.

My name is Dawn Comeau, and I am a Senior Director of Housing Programs, Property Management, Resident, and Inspection Services. I bring with me nearly 25 years of experience in the fast paced and always changing world of Affordable, Low-Income HUD Housing. I take pride in my ability to adapt quickly, communicate effectively, enforce policy while having empathy for those in need. I have always been given the opportunity of growth with the housing authority. This has allowed me to travel to national conferences, training conferences, gain certifications, and continue to build relationships and connect with others in the housing industry.

In 2019 I was awarded the Kimberly Wilson Community Transformation Award. I was recognized for advocating for victims and collaborating with landlords to help others understand the impact of domestic violence and homelessness. I had immense success in assisting families locating safe and stable housing after fleeing a domestic violence situation. I attribute successfully housing these survivors through my longstanding relationships I built with the landlords that participate with Auburn Housing Authority's HCV program.

In 2024 the Housing Authority partnered with the City of Auburn on a relocation project for 7 Chestnut Street, Auburn. The housing authority successfully relocated all the existing voucher holder tenants that resided at the Chestnut Street property. Using our deep-rooted relationships with landlords, assisting with direct referrals, constant networking, and information on units that were coming available. The housing authority also issued two new housing choice vouchers to market residents there. Both, who were happily relocated as well. The Authority

provided all income, assets, and inspection documentation to the City upon completion of the moves. The city was able to rely on the information we provided to prepare their relocation packages for all the program participants.

The Housing Authority was awarded the RFQ this Spring along with its partners, the City of Auburn and Spurwink to be part of the Home for Good project. This project will house the most chronically homeless individuals while providing wraparound services. I am excited to collaborate with my colleagues to not only to build this project but to be able to house individuals that are in need of the type of housing that this project will provide.

Most recently, the housing authority for its second year received the score of 100%, on its SEMAP (Section 8 Management Assessment Program) submission. We were also named as a

High Performer. I can attribute this to the improvements made to the overall process and

procedures. Taking the reins and undertaking this overhaul has been extremely rewarding. The

required documentation of plans and policies, excellent record keeping, and gathering of information from tenant files are a few examples. Recognition goes out to the entire team. The work performed in the housing department and information gathered from other departments combined has led us to successful scoring.

I continue to approach each task with dedication and a willingness to learn. I am known for being detail-oriented, dependable, and solution-focused with a commitment to deliver quality work with integrity and professionalism.
