The City Council of the City of Auburn is accepting sealed bids for the purchase of the City's interest in the following piece of property that is being offered for sale in "as is condition" with no warranties:

The tax maps and other public information concerning the properties may be reviewed at <u>www.auburnmaine.gov</u> or City Hall during its normal business hours, which are: Monday - Friday from 8:30 a.m. to 4:00 p.m.

Each bid must be in writing and in a sealed envelope marked "**2021-009 Tax Acquired Properties**" on the outside. Each bid may be for one property only; any person wishing to bid on several properties must submit a separate bid for each one. Bids must be submitted on bid specification sheets, which can be obtained from the Office of the Facilities Manager/Purchasing Agent, 60 Court Street, Auburn, ME 04210. All bids must be received at the Office of the Facilities Manager/ Purchasing Agent by **2:00 p.m. on Thursday, September 24, 2020**. Late bids will not be opened or considered. The City Council reserves the right to reject any or all bids.

Each bid must include the bidder's name, mailing address and phone number and must be accompanied by a deposit in the form of a certified check or money order, in an amount equal to or greater than 10% of the bid price. Each successful bidder's deposit will be credited to the total purchase price for that parcel. Deposits will be returned to the unsuccessful bidders. Any bid which does not contain the proper deposit will be rejected.

Each successful bidder shall have 30 days from the date of the bid acceptance in which to complete the purchase. Each property will be conveyed by a quitclaim deed without covenants. In the event that a successful bidder fails, for any reason, to complete the purchase in the time stated, the bid acceptance is void and the bidder's deposit shall be forfeited to the City. The City Council may thereafter negotiate a sale of the property with any or all unsuccessful bidders.
