This addendum amends and /or supplements the bid documents as indicated below. Only these items alter the bid documents. Any verbal discussions or responses are hereby declared null and void. Please acknowledge this addendum on the attached Bid Form.

Clarifications to the Bid Documents:

The following changes have been made to the Bid Documents:

- 1. Question: Will a copy of the sign in sheet be provided?
 - a. Answer Yes, the sign in sheet from the pre-bid meeting (held on September 5, 2023) is attached at the back of Addendum #1.
- 2. Question: Due to the time constraints on clearing for this year, will the office trailer or variable message boards be required to be installed for this work to take place?
 - a. Answer No, the job trailer and variable message boards will not be required for clearing.
- 3. Question: Please verify that CMP can do all of their work in the 10 days called out in the 104 spec.
 - a. Answer Gorrill Palmer will reach out to CMP to verify, a second addendum will be issued once the information is confirmed.
- 4. Question: Are there any special bedding/backfill requirements for the RCP?
 - a. Answer: There are no special bedding or backfilling requirements beyond what is specified in the Maine DOT Standard Specifications Section 603 Pipe Culverts and Storm Drains.
- 5. Question: How is bituminous tack paid for on this project?
 - a. Answer Item 409.15 Bituminous Tack Coat, Applied, has been added to the schedule of items (see attached). The last sentence in Special Provision 403-Hot Mix Asphalt (sheet 82), under Tack Coat, shall be replaced with the following sentence "Tack used will be **paid for at the contract unit price** for Item 409.15 Bituminous Tack Coat".
- 6. Question: Please clarify the locations, number, and types of signs to be installed under item 645.292?

- a. Answer Item 645.292 has been removed from the project (see attached updated schedule of items). Please refer to note 3, on sheet 14 of the plan set (signing and striping plans) Remove and reset all existing signs, payment shall be incidental to the project.
- 7. Question: Please clarify what type of herbaceous perennials are required?
 - a. Answer: The plans do not specify a certain type of herbaceous perennial; the intent is for the proposed plant material to match the existing plants in the vicinity. The Contractor shall confirm the plant type with the city prior to ordering the plants.
- 8. Question: How is the rigid insulation over the water pipes paid for?
 - a. Answer: Rigid insulation will be considered as incidental to the 603 items pipe culverts and storm drains. This supersedes the drainage note in the cross sections stating that it is incidental to the 605 items.
- 9. Question: Regarding the cellar drain detail (sheet 4), is the intent to pay for the connection from the proposed underdrain to the standpipe under item 605.10 6 Inch Underdrain Outlet? Could it be completed under the 801 items (sanitary sewer)?
 - a. Per Maine DOT Standard Detail 802(18), the connection will be paid for under item 605.10, 6 Inch Underdrain Outlet or as directed by the Resident.
- 10. Question: How will the project be awarded? Is it based on the combined price for both the based bid and bid alt#1?
 - a. Answer: Yes, the award is based on the combined price of the base bid as well as the bid alt #1. Once the project is awarded the City of Auburn will move forward with either the Base Bid (bituminous curb) or Bid Alt #1 (replace the bituminous curb with concrete slipform curb). The intent is to get competitive pricing for both curb options for the City of Auburn.
- 11. Question: Were the trees marked out that you wanted cut? The bid tab and plans show different quantities, and we would like clarification on which trees are to be paid for and which ones are considered incidental?
 - a. Answer: The tree and stump removal quantities noted in the schedule of items match the construction notes shown on sheet 6 of the plan set. Per Maine DOT Standard Specifications, Division 200 Section 201: Clearing Right-of-Way, "a single tree is defined as any tree or remains of a tree, still standing, 12 inches or more in its average diameter measured as specified in Subsection 201.09 Method of Measurement, and taller than 5 feet measured from the ground at the base of the tree". Trees that are noted on the plans to be removed but are not noted in the construction notes are assumed to not meet the criteria above and are considered incidental to the project.
- 12. Question: How are the white reflectorized delineator posts, called out on sheet 15, being paid for?

- a. Answer: The nine (9) white reflectorized delineator posts, called out in the Signing and Striping Plans (sheet 15), will be paid for under Item 606.356 Underdrain Delineator Post.
- 13. Please clarify the locations for the 26 underdrain delineator posts called out under item 606.356?
 - a. Answer: Per General Note 52, on sheet 5 of the plan set, a delineator post (item 606.356) will be installed at each end of a run of bituminous curb. There will also be a delineator post located at each underdrain outlet (6" and 12"), see the construction notes (sheet 6) for specific locations. In addition, the nine (9) white reflectorized delineator posts, called out in the Signing and Striping Plans (sheet 15), will be paid for under item 606.356.
