**Q: What does the 3,000 mean?**

A: This was the quantity in Linear Feet for the work to be done, please reference the attached updated bid form. The City has changed the Unit from Linear Foot to Hourly pricing.

**Q: Does traffic control have to be on its own line item, or can it be added into the cost of the Tree Removal line?**

A: It can be added to the unit price for the Tree Removal line, just leave the traffic control line blank.

**Q: What is the timeline of completing the work?**

A: June 30<sup>th</sup>, 2026.

**Q: Why is the roadside trimming requested in Linear Foot and not Hourly?**

A: The City has changed the bid form from Linear Foot to Hourly, please see the attached bid form.

**Q: If while performing roadside trimming the Contractor comes across a hazard tree, how is this going to be paid for?**

A: This will be paid under the hourly price for roadside trimming.
