This addendum amends and /or supplements the bid documents as indicated below. Only these items alter the Bid Documents. Any verbal discussions or responses are hereby declared null and void.

Clarifications to the Bid Documents:

The following changes have been made to the Bid Documents:

- 1. Traffic detail by Auburn Police will be required when working at the intersection of Washington Avenue South. Item 652.381 Traffic Officers will be added with an estimated quantity and set hourly rate. Auburn PD will invoice the contractor directly. See attached bid form.
- 2. Existing culverts/catch basins will be cleaned/jetted by Auburn Public Works.
- 3. For additional railroad flagging protection beyond the two 8 hour days provided at no charge; the daily rate for flagger protection while working within the ROW of the railroad will be \$1,000 per day based on an 8 hour day, minimum 8 hours per day. For each additional hour beyond eight, the rate will be \$125.00 per hour.
- 4. Work conducted within 30' of the railroad crossing shall require railroad flagger protection.
- 5. The Railroad (St. Lawrence & Atlantic) have no improvements planned between the tracks at the crossing.
- 6. Butt joints in areas adjacent to raised center islands shall be milled to maintain curb reveal and will taper to zero beyond the end of the island at a minimum distance for proper constructability. All Pavement Butt Joint lengths shall be determined in the field by the Resident.
