Subject: Calling a Special Municipal Referendum Election and approving the Referendum Question Language

Information: The School Department would like to include a referendum question on a ballot to voters at the June 12, 2018 Election. The proposed question being:

Do you approve Auburn School Department joining a regional service center with other area school districts in order to improve educational efficiencies and preserve state subsidy, as set forth in an application to be approved by the Commissioner of the Maine Department of Education?

City Budgetary Impacts: The Auburn School Committee recommends that Auburn School Department enter into a Regional Service Center with RSU 16 and MSAD 52. Under new state law, and per the Dept. of Education, "new opportunities are now available to provide support for regional efforts that will improve opportunity and access for Maine students by economizing on and maximizing educational services".

If voters approve Auburn's membership in the service center, Auburn School Department will receive an additional \$98,467 in state subsidy in FY 19. It is anticipated that Auburn will receive approximately \$200,000 in additional state subsidy for FY 20. Additionally, the center itself will receive direct funding of \$97,200 in FY 19, which will be used to cover expenses of the service center, thereby benefiting its member districts.

Staff Recommended Action: Recommend passage which will allow voters to decide whether or not they would like the Auburn School Department to join a regional service center with other area school districts.
