IT Director's Report

Radio Project Update

- IT Director McKinley advised the committee that EF Johnson found a hardware configuration change that they believe is the cause of the audio issues with the dispatcher consoles. New hardware has been ordered and is anticipated to arrive within the next few weeks.
- The FSA (fire station alerting) hardware is ready and is on track for April or May installation.
- The Fifth Site Radio Tower at the Auburn Lewiston Municipal Airport is still waiting on final FAA approval to run power lines underground. Once the approval letter has been received, the connection should be up and running within a month's time.

Operations Manager's Report:

- Director Hall advised the Committee that he would like to post for the vacant Operation's Manager position in April. He anticipates an internal candidate will fill the position and hopefully be selected by May.
