### **Assessing**

- Staff researched the effect of a Maine Turnpike Authority easement on the valuation of Industrial land at the request of a taxpayer.
- Splits and merges were researched and updated in the system.
- Veteran's Exemptions were reviewed and loaded in the CAMA system for the upcoming tax year.
- The interrogatory letter was sent to Lowe's Home Centers in response to the abatement application filed.
- The tax representative filed an abatement request for the Cascades Auburn Fiber facility located on Lewiston Junction Road. As the first step to receiving the application staff has begun to working on the interrogatory letter.
- In order to ensure accuracy with the ownership and sales information loaded in the CAMA system, all staff proofs the data. The deeds and declarations of value have been proofed through October. This leaves only November to proof to be completely up to date.
- The invitations for the Business Personal Property Forum to be held the afternoon of February 23<sup>rd</sup> and the morning on February 26<sup>th</sup> in the Community Room of Auburn Hall have been sent and posted on the Community Calendar, Assessing web page, Assessing News and social media.

### **Human Resources**

- Staff provided benefits orientation for two new Public Services Department Equipment Operators.
- Staff met with a representative of Kaplan University to discuss potential employment/work experience opportunities for Work Study students. The salary is paid through Kaplan, therefore there are no costs for the employer, other than supervision and creating valuable work experiences for the student. Students may be enrolled in a variety of academic and technical programs.
- In recognition of Heart Month, several members of the City Wellness Team attended a luncheon presentation by two noted Lewiston physicians, Dr. McCann and Dr. Erickson. The topics were Cancer Treatment Options and Cardiovascular Disease; Prevention and Minimizing Risks in Women.
- Staff from Human Resources Department and Recreation Department met to discuss hiring procedures for the Summer Camp Program.

## IT

- Working with Planning, Public Safety, Assessing and Code Enforcement, staff gathered, formatted and mapped datasets from each department (Building Permits, Number of Buildings/Units, Owner Occupied status, Vacant Buildings, Code Requests, Assessed Property Values, Public Safety calls and crime) in an effort to provide baselines for a Neighborhood Revitalization strategy. Once the data sets were formatted and mapped, we were able to combine each of these data layers with existing map layers, assemble statistics and look for hotspots. The results of this were integrated into a map journal and presented at the City Council workshop as an interactive map presentation. This project required us to put most of our other efforts on the back burner for the week.
- Attended a conference call with Public Services and a implementation specialist from Lucity , our Work Order/Asset management software application. We reviewed the outstanding task list, from their visit last fall, and put together a work plan to address outstanding tasks.

## **Planning**

- The City Planner was out for 3 weeks due to a medical leave and planned vacation and we are pleased to have him back.
- Eric Cousens and the City Planner presented the draft Form Based Code to the City Council at a workshop on Monday, February 8. The presentation was well received and the Council asked to move the proposal forward to a first reading and public hearing at the Council's first meeting in March.
- The City Planner led the Planning Board's Tuesday, February 9<sup>th</sup> meeting. A cell tower proposal at 200 Merrow Road was approved and the final draft of an Adaptive Re-use zoning text amendment had a public hearing and final review by the Planning Board. The final draft, along with a Planning Board report will be forwarded on to the City Council for their consideration.
- Staff is working on budget and combining the departments of Planning and Permitting, Economic Development and Community Development.
- We are getting preliminary surveys and reports back on the New Auburn Village project

## **Police**

- The department handled 531 calls for service this week. Officers conducted 131 motor vehicle stops and investigated 72 offenses of which, 7 of which were felonies, generating 20 arrests, 30 criminal summonses and one juvenile arrest. Officers responded to 29 motor vehicle crashes.

## **Public Services**

- All shifts were very busy Monday into Tuesday plowing, sanding and salting Auburn's roads. The snow came in quick and lasted long. With the road and air temperatures conditions, plowing was making it hard to keep the roads cleared.
- Crews were busy all week removing snow from the Downtown area, Drummond St, Main St, Newbury St.
- The sidewalk crews were on a continuous schedule keep all sidewalks cleared.

- Fleet have been working hard on keeping the trucks up and running making them safe for the road
- Crews were busy loading trucks, keeping the calcium tank and salt shed filled and cleaned
- The welding shop has been working on wing repairers and plows, as well as working on small jobs and making new plates in dump number 6 truck and finish up chipper boxes and gate
- Crews continue to focus on the mandatory Bureau of Labor Standard requirements
- The hot patching crew was out at Auburn Heights, Elm, and Gracelawn Rd as well as others areas in need of patching
- Third shift crews were out on the roads spot sanding icy areas
- The Excavation Technician was busy marking out dig safe's, inspecting both private and street excavations, reviewing and issuing Fill, Drive Opening permits as well as billing and continues GIS work
- Sign work around the city continues. Staff are replacing and or fixing faded and damaged signs in accordance with the new regulations.
- Crews were directed to pick up a few items left on the side of the road (debris, T.V.'s, mattresses, tires, etc.)
- 2016 Reclamation Project (Townsend Brook Road, Pettingill Park)- project has been awarded to Gendron & Gendron, start date anticipated for early May
- 2016 Reconstruction Project ( Highland Ave, Library Ave, Troy St)- project is in design phase
- 2016 MPI Project (South Main Street)- project is in design phase
- Summer Street Extension- public meeting held on 1/6, project to be advertised for bid with a Spring/Summer construction schedule
- Stormwater Compliance- on-going
- Hillcrest Ave Retaining Wall- project to be advertised as design build
- Fish Hatchery Road- researching grant to add a culvert to allow fish passage and eliminate constant flooding issues
- Ash Landfill sewer force main- conducting a feasibility study for pumping leachate from retaining pond to eliminate the need for the yearly expense of hauling
- The City Engineer was notified the City received the approved grant for Tree Inventory. Bid documents will be put out as soon as possible.

### **Recreation**

- Winter Festival – Final wrap up meeting will be this tomorrow, Friday Feb 12, where we will discuss any plans and feedback from this past year and choose a date for next year's festival. Overall feedback from the public was very positive.
- Youth Basketball – Practices and games still going well so far. No major injuries.
- Youth Travel Basketball – Evaluations for this new program have been completed. Kids have been notified whether or not they made the team and coaches will be starting practices next week.
- Adult Basketball – Season is going well. No major injuries or issues this year.
- Vacation Day Camp – We are not holding a February Vacation Day Camp, due to lack of proper staffing. However, we will be moving forward with an April Vacation Camp. Cost

will be \$75 for the week and registrations will open mid March. People are very excited about this program and we expect a strong turnout.

- Ski & Snowboard Lessons – This program has gone very well so far. People are excited about the partnership between our department and the local ski mountain. We will be approaching our final week of lessons next week. Next year we plan to broaden our partnership and include a ski club as well as lessons, which will offer transportation after school out to the mountain for the evening.
- Indoor Soccer – indoor soccer is going well so far. No major issues or concerns of any kind. This coming Sunday will be the final week of the program.
- Father Daughter Dance – We have sold a total of 90 tickets up to this point. People are very excited about this program. With one more week of ticket sales we expect to clear 100 attendees.
- Art Walk – March meeting has been cancelled.
- Summer Camp – Planning is well underway. Returning staff has all been notified and we will be posting for any open positions early next week. We have increased the fee for this summer by \$50, bringing the total registration cost to \$550. We have opened registration already, allowing people more time to pay on their account.
- Cheering – Season is coming to a close. They are still looking into the possibility of a summer season.
- Lacrosse – Planning for this program is still ongoing.
- Dodge ball – Season will begin March 16<sup>th</sup>. Program will last 9 weeks and run on Wednesday and Friday evenings.
- Fishing Derby – Will be held May 7<sup>th</sup> and May 14<sup>th</sup> (Saturdays) at the Pettengill Pond. Cost will be \$5 per child.
- April Soccer Camp – Maine Premier Soccer will be offering an April soccer camp. Program will be held at the lower baseball fields and will be available the week of April Vacation in the afternoons.
- Recess Warrior – Program aimed at kids ages 3 to 7. Each week is a different sport where kids will learn the basics of each one. Cost is \$35, program is 5 weeks on Saturday mornings starting April 9<sup>th</sup>.
- Spring Celebration – Free games and activities offered to kids and families on March 26<sup>th</sup>. Great community event which is completely free for families.
