- 1. Introductions
  - a. Richardson Associates will be on the team providing landscape architectural services
- 2. Review Study Scope of Work
  - a. Need to consider whole coordinated signal corridor up to Main & Sabattus
- 3. Existing Conditions Summary/Data Collection
  - a. Auburn Police Department can place speed data collection equipment along corridor upon request
    - i. Tim Cougle indicated that the police department has not historically gotten speed complaints in the study area
    - ii. Speeds are likely to be higher outside of peak hours, and even more so in the evening
  - b. MaineDOT may be able to provide performance data for the last two years in the study area
  - c. Tom already has access to and will be using StreetLight data i. Origin/Destination data
  - d. Upon preliminary review of traffic count data, Tom noticed that pedestrian levels are unusually low
  - e. TYLin will be working with ATRC to look at traffic growth model
  - f. There are currently five (5) high crash locations in study area
    - i. Tom will be working with APD and MaineDOT to get police reports for crashes
  - g. ATRC will conduct a turning movement count at the intersection of Court St. and Goff St.
  - h. Afternoon commuter hour seems to be shorter (PM Peak hour has higher traffic volumes than AM Peak)
    - i. Midday traffic volumes seem to be higher than morning volumes
  - i. Condition is not currently an issue, no reconstruction or rehab on the horizon

- 4. Public Meeting/Public Outreach Process
  - a. First public meeting will gather initial concerns and thoughts from public
- 5. Project Schedule
  - a. Next committee meeting will be held around July 12<sup>th</sup>
  - b. First public meeting will be held around July 25<sup>th</sup>
  - c. Scheduling Notes:
    - i. Business hours work best for majority
    - ii. Mondays are not good
    - iii. Friday mornings seem to work well
- 6. Comments/Concerns
  - a. Access management along corridor has been a big issue and is hard to enforce
  - b. Not much current pedestrian activity and traffic is often unfriendly to pedestrians (honking, etc.)
  - c. Spring St. sidewalk had been closed for a few years for construction
  - d. Wayne from FHWA indicated that a leading pedestrian phase has worked well in other places and may be appropriate here
  - e. Topography is a big issue and will need to be considered
  - f. Recently and soon to be constructed housing units will likely increase pedestrian activity
    - i. Need to consider additional foot traffic from housing units on north side to Hannaford on south side
  - g. Tom will give some comparative traffic volumes to compare corridor to other locations throughout the state
  - h. The City of Auburn is looking at reconstructing Library Dr., Spring St., etc. to Hampshire St.
  - i. Need to consider possible expansion of Goff St. to accommodate possible new medical facility
  - j. Pleasant St. has an unsignalized pedestrian crossing that will need to be looked at
  - k. Parking along North side of Court St. would provide additional refuge for pedestrians
  - I. Train comes through area 3-4 times daily, possible ITS advanced warning solutions should be looked at
  - m. Lighting along corridor will be generally examined
  - n. Land use and new development in Lewiston needs to be considered
- 7. Next Steps
  - a. TYLin will continue to examine existing conditions
  - b. ATRC will conduct a turning movement count at Court and Goff
  - c. Committee will begin to shape direction of study at next meeting
